Re: Notice of Data Event

Dear Sir or Madam:

We represent Aero Fulfillment Services (“AFS”), located at 3900 Aero Drive, Mason, OH 45040, and are writing to notify your office of an incident that may affect the security of some personal information relating to approximately one (1) Maryland resident. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, AFS does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about January 20, 2022, AFS discovered anomalous activity within its computer network. AFS immediately launched an investigation, with the assistance of third-party cybersecurity specialists, to determine the nature and scope of the event. The investigation determined that between January 12, 2022 and January 20, 2022, an unauthorized actor gained access to certain AFS systems and that certain information in those systems was potentially accessible to the unauthorized actor.

AFS conducted a review of the information within those systems to identify the individual with personal information that was potentially accessible. AFS concluded this review on March 2, 2022. The information that could have been subject to unauthorized access includes name, address, date of birth, Social Security number, and financial account information.

Notice to Maryland Resident

On or about April 4, 2022, AFS began providing written notice of this incident to affected individual, which includes one (1) Maryland resident. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, AFS moved quickly to investigate and respond to the incident, assess the security of its systems, and notify the potentially affected individual. AFS is also working to implement additional safeguards and training to its employees. AFS is providing access to credit monitoring services for twelve (12) months, through Experian, to the individual whose personal information was potentially affected by this incident, at no cost to this individual.

Additionally, AFS is providing the impacted individual with guidance on how to better protect against identity theft and fraud, including advising the individual to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. AFS is providing the individual with information on how to place a fraud alert and credit freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

NOTICE OF SECURITY INCIDENT

Dear Sample A. Sample:

As you are aware, Aero Fulfillment Services (“AFS”) is writing to inform you of a recent event that may impact the security of some of your information. Although we have received no indication of any actual or attempted misuse of your information as a result of this event, this notice provides information about the event, our response, and resources available to you to help protect your information from possible misuse, should you feel it is necessary to do so.

What Happened? On January 20, 2022, AFS discovered anomalous activity within its computer network. AFS immediately launched an investigation, with the assistance of third-party cybersecurity specialists, to determine the nature and scope of the event. The investigation determined that between January 12, 2022 and January 20, 2022, an unauthorized actor gained access to certain AFS systems and that certain information in those systems was potentially accessible to the unauthorized actor. Therefore, we conducted a review of the information within those systems to identify individuals with personal information that was potentially accessible. We concluded this review on March 2, 2022. Although we are unaware of any actual or attempted misuse of your personal information, we are providing you this notice out of an abundance of caution.

What Information Was Involved? The investigation determined that your name, address, [Extra1] were potentially accessible.

What We Are Doing. The confidentiality, privacy, and security of information in our care are among our highest priorities. Upon learning of the event, we moved quickly to investigate and respond to the event, assess the security of our systems, and notify potentially affected individuals. We are notifying potentially affected individuals, including you, so that you may take further steps to best protect your information, should you feel it is necessary to do so. We regret any inconvenience or concern this event may cause. As an added precaution, and although we do not have any indication of any actual or attempted misuse of your personal information, we are offering credit monitoring and identify theft protection services through Experian for twelve (12) months at no cost to you.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
