Re: Notice of Security Incident

To Whom it May Concern:

I am writing on behalf of Compressed Gas Association (CGA), a trade association for the industrial and medical gas supply industries, to inform you that notices will be sent to four (4) Maryland residents regarding a security incident in which CGA was the target of a sophisticated ransomware attack that could have resulted in certain personal information being accessed without authorization.

I. Nature of the Security Incident.

On April 12, 2022, CGA was the victim of a sophisticated ransomware attack. Upon discovery of this incident, we immediately secured our network, implemented measures to further improve the security of our systems, safely restored our systems via viable backups, and notified law enforcement. Although we have no evidence of actual or attempted misuse of any individual's personal information, we cannot guarantee that files containing personal information were not accessed or extracted. Such files contain the name and social security number of potentially affected Maryland residents.

II. Number of Residents Affected and Notified.

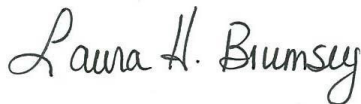
Four (4) Maryland residents could have been affected by the incident. Notice to the Maryland residents will be sent via first class mail on May 27, 2022.

III. Steps CGA has Taken to Address the Incident.

To help protect against a similar attack in the future, we have implemented additional measures designed to enhance the security of our network and systems. We also will offer, free of charge, 24 months of credit monitoring, fraud consultation, and identity theft restoration services through Experian. Dear Sample A. Sample:

We write to inform you about a recent data incident experienced by the Compressed Gas Association (CGA), a trade association for the industrial and medical gas supply industries, that may have involved some of your personal information. While we are unaware of any attempted or actual misuse of your information, we are providing you with information about the incident and steps you can take to protect yourself, should you feel it necessary to do so.

What Happened? On April 12, 2022, CGA was the victim of a sophisticated ransomware attack. Although we were able to recover our system through backups, we cannot determine whether the intruders accessed or extracted any files. Because we cannot guarantee that files containing your personal information were not accessed, we are providing you this notice. Presently, we have no evidence of actual or attempted misuse of your personal information.

What Information Was Involved? The personal information that was potentially accessible on our system contained your name and [Extra1].

What We are Doing. Upon discovery of this incident, we immediately secured our network, implemented measures to further improve the security of our systems, safely restored our systems via viable backups, and notified law enforcement. In addition, we are notifying you so that you may take further steps to protect your information, should you feel it appropriate to do so. We also are providing you with access to 24 months of credit monitoring and identity restoration services through Experian at no charge to you. You must enroll by August 31, 2022.

What You Can Do. Please review the enclosed "*Steps You can take to Help Protect Your Information*," which describes the services we are offering and how to activate them, and provides further details on how to protect yourself. We encourage you to remain vigilant against the potential for identity theft and fraud and to monitor your credit reports for any potential suspicious activity.

Enroll in Complimentary Identity Monitoring Services

We are providing you with a 24-month membership of Experian's IdentityWorks. A credit card is not required for enrollment in the identity monitoring services. To enroll, at no cost to you,

If, after discussing your situation with an agent, it is determined that Identity Restoration support is needed, then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

Free Credit Report

Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus (Equifax, Experian, and TransUnion). Obtaining a copy of your credit report from each agency on an annual basis, and reviewing it for suspicious activity, can help you spot problems and address them quickly. You can request your free credit report online at www.annualcreditreport.com or by phone at 1-877-322-8228. You can also request your free credit report by completing the request form at: www.annualcreditreport.com, and mailing it to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348-5281. You may wish to stagger your requests so that you receive a free report by one of the three credit bureaus every four months.

Fraud Alert

As a precaution against identity theft, you can consider placing a fraud alert on your credit file. A "fraud alert" tells creditors to contact you before opening a new account or changing an existing account. A fraud alert also lets your creditors know to watch for unusual or suspicious activity. To place a fraud alert, call any one of the three major credit reporting agencies listed below. An initial fraud alert remains effective for ninety days, and is free of charge. If you wish, you can renew the fraud alert at the expiration of this initial period. As soon as one credit agency confirms your fraud alert, the others are notified to place fraud alerts on your file.

Security Freeze

Under the law, you have the right to obtain any police report filed in regard to this incident. If you are the victim of identity theft, you also have the right to file a police report and obtain a copy of it.

Federal law also allows consumers to place, lift or remove a security freeze on their credit reports at no charge. A security freeze prohibits a credit reporting agency from releasing any information from a consumer's credit report without written authorization. Be aware that placing a security freeze on your credit report may delay, interfere with, or prevent the timely approval of any requests you make for new loans, credit mortgages, employment, housing, or other services.

To place a security freeze on your credit report, you must send a written request by regular, certified, or overnight mail at the addresses below to each of the three major credit reporting agencies: Equifax (www.equifax.com); Experian (www.experian.com); and TransUnion (www.transunion.com). You may also request the security freeze through each of the credit reporting agencies' websites or over the phone:

In order to request a security freeze, you will need to provide the following information:

1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security Number;
3. Date of birth;
4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years;
5. Proof of current address such as a current utility bill or telephone bill;
6. A legible photocopy of a government issued identification card (state driver's license or ID card, military identification, etc.);
7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft; and
8. If you are not a victim of identity theft, include payment by check, money order, or credit card (Visa, MasterCard, American Express or Discover only). Do not send cash through the mail.

The credit reporting agencies have three (3) business days after receiving your request to place a security freeze on your credit report. The credit bureaus must also send written confirmation to you within five (5) business days and provide you with a unique personal identification number (PIN) or password, or both that can be used by you to authorize the removal or lifting of the security freeze.

To lift the security freeze in order to allow a specific entity or individual access to your credit report, you must call or send a written request to the credit reporting agencies by mail and include proper identification (name, address, and social security number) and the PIN number or password provided to you when you placed the security freeze as well as the identities of those entities or individuals you would like to receive your credit report or the specific period of time you want the credit report available. The credit reporting agencies have three (3) business days after receiving your request to lift the security freeze for those identified entities or for the specified period of time.

To remove the security freeze, you must send a written request to each of the three credit bureaus by mail and include proper identification (name, address, and social security number) and the PIN number or password provided to you when you placed the security freeze. The credit bureaus have three (3) business days after receiving your request to remove the security freeze.
