Re: Notice of Data Event

Dear Sir or Madam:

We represent Deutsch Kerrigan LLP (“Deutsch Kerrigan”) located at 755 Magazine Street, New Orleans, LA 70130, and write to notify your office of an incident that may affect the security of certain personal information relating to one (1) Maryland resident. The investigation into this matter is ongoing, and this notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Deutsch Kerrigan does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

On November 15, 2021, Deutsch Kerrigan discovered suspicious activity related to certain servers within its environment. Deutsch Kerrigan immediately took steps to secure our network, and launched an investigation, with the assistance of third-party experts, to determine the nature and scope of the incident. The investigation determined that Deutsch Kerrigan was the target of a cyber-attack that impacted its network and that certain files on Deutsch Kerrigan’s network were subject to unauthorized access. As such, the contents of those files were reviewed to determine what information was contained therein and to whom it related. Upon completion of the review and verification of the data, Deutsch Kerrigan notified individuals and relevant regulators as soon as possible.

The information that could have been subject to unauthorized access includes name and Social Security number.

Notice to Maryland Resident

On or about June 2, 2022, Deutsch Kerrigan provided written notice of this incident to one (1) Maryland resident. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, Deutsch Kerrigan moved quickly to investigate and respond to the incident, assess the security of Deutsch Kerrigan systems, and identify potentially affected individuals. Further, Deutsch Kerrigan notified federal law enforcement regarding the event. Deutsch Kerrigan is also working to implement additional safeguards and training to its employees. Deutsch Kerrigan is providing access to credit monitoring services for two (2) years through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Deutsch Kerrigan is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Deutsch Kerrigan is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

NOTICE OF [SECURITY INCIDENT] / [DATA BREACH]

Dear Sample A. Sample:

Deutsch Kerrigan LLP (“Deutsch Kerrigan”) writes to make you aware of an incident that may affect the security of some of your personal information. This notice provides information about the incident, our response, and resources available to you to help protect your personal information from possible misuse, should you feel it is appropriate to do so.

What Happened? On November 15, 2021, Deutsch Kerrigan discovered suspicious activity related to certain servers within its environment. We immediately took steps to secure our network, and launched an investigation, with the assistance of third-party experts, to determine the nature and scope of the incident. Through the investigation, we determined that Deutsch Kerrigan was the target of a cyber-attack that impacted our network. The investigation determined that certain files on our network were subject to unauthorized access. As such, we reviewed the contents of those files to determine what information was contained therein and to whom it related. We are notifying you because your personal information was contained in the impacted files.

What Information Was Involved? Our investigation determined that the following information may have been impacted by this incident: your name, [Extra1][Extra2][Extra3][Extra4].

What We Are Doing. The security of information in Deutsch Kerrigan’s care is one of our highest priorities, and we have strict security measures in place to protect information in our care. Upon becoming aware of this incident, we immediately took steps to confirm the security of our systems. While we had policies and procedures in place at the time of incident regarding security of information, we are reviewing those existing policies and procedures to further protect against similar incidents moving forward. We are notifying potentially impacted individuals, including you, so that you may take steps to best protect your information, should you feel it is appropriate to do so. We are also reporting to regulatory officials, as required.

As an added precaution, we are offering you access to credit monitoring and identity theft protection services for 24 months at no cost to you, through Experian IdentityWorksSM. You may find information on how to enroll in these services in the enclosed “Steps You Can Take to Help Protect Personal Information.” We encourage you to enroll in these services as we are not able to do so on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Please also review the information contained in the enclosed “Steps You Can Take to Help Protect Personal Information.”

Enroll in Credit Monitoring

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for 24 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

A credit card is not required for enrollment in Experian IdentityWorks. You can contact Experian immediately regarding any fraud issues, and have access to the following features once you enroll in Experian IdentityWorks:

- **Credit Monitoring:** Actively monitors Experian file for indicators of fraud.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
