Re: Incident Notification

Dear Attorney General Frosh:

We are writing on behalf of our client, LCG, Inc. ("LCG"), to notify you of a security incident.

LCG recently concluded an investigation regarding a cybersecurity incident involving unauthorized access to the LCG network. Upon discovery, LCG immediately took steps to secure the network. A cybersecurity firm was engaged, and the investigation determined that an unauthorized party was able to access to the network, between February 12, 2022, and March 9, 2022. The investigation was unable to determine what the unauthorized actor accessed. Accordingly, a thorough review was conducted of the network to identify any personal information that may have been accessed. LCG completed that review on June 27, 2022 and determined that the information involved contained the names and Social Security numbers, and/or financial account numbers of 455 Maryland residents.

On September 13, 2022, LCG is providing written notice via United States Postal Service mail to the Maryland residents whose information was involved in accordance with Md. Code Ann., Com. Law § 14-3504. A copy of the notification letter is enclosed.¹ LCG has arranged for eligible individuals whose Social Security number was involved to receive one year of complimentary

identity monitoring services. LCG is also providing a toll-free phone number for letter recipients to call for further information about the incident.

To help further protect against an incident like this, LCG is taking steps to further enhance the security of its network.

LCG, Inc. ("LCG") recognizes the importance of protecting the information we maintain. We are writing to inform you of an incident that may have involved some of your personal information. This notice explains the incident, measures we have taken, and additional steps you may consider taking in response.

We recently concluded an investigation regarding a cybersecurity incident involving unauthorized access to the LCG network. Upon discovery, we took steps to secure the network and commenced an investigation, which revealed that an unauthorized party accessed a limited number of servers in our network between February 12, 2022, and March 9, 2022.

We conducted a review of files on the involved servers to identify any personal information that may have been accessed during the incident. We completed that review on June 27, 2022 and determined that the information involved contained your Social Security number, and/or financial account number.

We encourage you to remain vigilant by reviewing your account statements and credit reports for any unauthorized activity. We are offering you a free one-year membership in Experian's® IdentityWorksSM Credit 3B. This product provides you with identity detection and resolution of identity theft. IdentityWorks Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. For more information on IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, as well as some additional steps you can take in response, please see the pages that follow this letter.

We regret this incident occurred and apologize for any inconvenience. To help prevent something like this from happening again, we have implemented additional measures to enhance our existing security protocols.

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. Contact information for the Federal Trade Commission is as follows:

Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

You also have a right to place a security freeze on your credit report, as described above.

A Summary of Your Rights Under the Fair Credit Reporting Act: The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit "prescreened" offers of credit and insurance you get based on information in your credit report.
- You have a right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
