We write on behalf of our client Emtec, Inc. ("Emtec") to notify you that Emtec recently became aware of a data security incident affecting Emtec's systems. Emtec is reviewing this incident and has determined that certain data files were accessible to unauthorized third parties for a period of time. Emtec subsequently performed an assessment of these data files and determined, on September 14, that some of the files contained certain personal information for 1 resident of Maryland. Emtec's review to date indicates that the unauthorized access to files containing personal information may have begun on September 7, 2022 and was terminated on September 14, 2022.

After becoming aware of the incident, Emtec undertook a review, working with third party experts and law enforcement, to determine the nature and scope of the unauthorized access and ensure it was contained. After Emtec terminated the unauthorized access, Emtec implemented additional security measures to help further protect against this type of incident going forward. After conducting a comprehensive analysis of the compromised data to determine the affected individuals, Emtec determined that the incident potentially affected 1 Maryland resident's Social Security number.

Emtec is taking action to provide assistance to potentially affected individuals. Emtec will notify affected individuals by mail on October 14, 2022 and will provide 24 months of credit monitoring services from TransUnion. Emtec has also provided information about steps that individuals can take to protect themselves, such as regularly monitoring financial statements and credit reports. A template copy of the notification letter Emtec has sent to affected Maryland residents is attached to this notice as Appendix A.

Emtec, Inc. ("Emtec") recently became aware of a ransomware event resulting in unauthorized access to Emtec systems. We are reviewing this incident and have determined that certain data files were accessible to unauthorized third parties for a period of time. We subsequently performed an assessment of these data files and determined, on September 14, that some of the files contained certain personal information at the time that the unauthorized third party had access to them. Our review to date indicates that the unauthorized access to files containing personal information may have begun on September 7, 2022 and was terminated on September 14, 2022.

### What Information Was Involved

Emtec is reviewing this incident and has determined that certain data files were accessible to unauthorized third parties for a period of time. Emtec subsequently performed an assessment of these data files and determined, on September 14, that some of the files contained certain personal information for 1 resident of Maryland. These individuals were notified on October 14. On November 24, Emtec determined that additional files contained certain personal information for an additional 70 residents of Maryland. Emtec's review to date indicates that the unauthorized access to files containing personal information may have begun on September 7, 2022 and was terminated on September 14, 2022.

After becoming aware of the incident, Emtec undertook a review, working with third party experts and law enforcement, to determine the nature and scope of the unauthorized access and ensure it was contained. After Emtec terminated the unauthorized access, Emtec implemented additional security measures to help further protect against this type of incident going forward.

Emtec is taking action to provide assistance to potentially affected individuals. Emtec previously notified affected individuals by mail on October 14, 2022 and will notify newly discovered affected individuals by mail on December 23, 2022. All affected individuals are provided with 24 months of credit monitoring services from TransUnion. Emtec has also provided information about steps that individuals can take to protect themselves, such as regularly monitoring financial statements and credit reports. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting 7 years. Should you wish to place a fraud alert, please contact any one of the agencies listed below. The agency you contact will then contact the other two credit agencies.
