Re: Notice of Data Event

To Whom It May Concern:

We represent Amotec, Inc. (“Amotec”) located at 1701 East 12th St., Suite 103, Cleveland, OH 44114, and are writing to notify your office of an incident that may affect the security of certain personal information relating to forty-two (42) Maryland residents. This notice may be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Amotec does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

On December 26, 2022, Amotec discovered suspicious activity in its network. Amotec immediately took steps to secure its systems and initiated an investigation into the nature and scope of the event with the assistance of third-party computer forensic specialists. The investigation determined that an unknown actor gained access to certain computer systems on its network, and on or about December 26, 2022, may have accessed and/or acquired certain files from these systems. In response, Amotec reviewed the affected files in order to identify what information is contained therein and to whom the information relates. On January 23, 2023, Amotec completed its review and moved quickly to identify the address information of the potentially impacted population. Amotec has no evidence that the information was actually viewed by the unknown actor, but is unable to rule out this possibility. Furthermore, Amotec is not aware of any actual or attempted fraudulent misuse of any individual’s information as a result of this incident.

The information potentially impacted by this event includes the following: name, Social Security number, driver’s license number, and financial account information.

Notice to Maryland Residents

On February 10, 2023, Amotec provided written notice of this incident to forty-two (42) Maryland residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Amotec moved quickly to investigate and respond to the incident, assess the security of its systems, and identify potentially affected individuals. Further, Amotec notified federal law enforcement regarding the event. Amotec is also working to implement additional security measures and training to its employees to protect against similar incidents moving forward. Amotec is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Amotec is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Amotec is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Amotec is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

Amotec, Inc. (“Amotec”) is writing to notify you of an incident that occurred on our systems that may have impacted the privacy of some of your personal information. We sincerely apologize that this incident occurred, and are providing you with information about the incident, our response to it, and resources we are making available to you to help protect your information, should you wish to do so.

What Happened? On December 26, 2022, Amotec discovered suspicious activity in our network. We immediately took steps to secure our systems and initiated an investigation into the nature and scope of the event with the assistance of third-party computer forensic specialists. The investigation determined that an unknown actor gained access to certain computer systems on our network, and on or about December 26, 2022, may have accessed and/or acquired certain files from these systems. In response, we reviewed the affected files in order to identify what information is contained therein and to whom that information relates. On January 23, 2023, we completed our review and determined that personal information related to you may have been impacted by this event. We are unaware of any actual or attempted fraudulent misuse of your information as a result of this incident.

What Information Was Involved? The information related to you that may have been impacted by this event includes your name, [variable text 2]. The investigation was unable to determine whether your specific information was actually viewed or acquired, and we have no evidence of any actual or attempted identity theft or fraud resulting from this event.

What We Are Doing. The confidentiality, privacy, and security of personal information is among Amotec’s highest priorities, and we have strict security measures in place to protect information in our care. Upon becoming aware of this incident, we immediately took steps to secure our systems and performed a full investigation. We have implemented additional security measures to further protect against similar incidents moving forward. We also reported this incident to federal law enforcement.

Additionally, we are offering credit monitoring and identity protection services for 12 months through Experian at no cost to you. The deadline to enroll in these services is May 31, 2023. Please note that you will not be automatically enrolled in these services. Should you wish to do so, you will need to enroll yourself in these services, as we are not able to do so on your behalf. You may find instructions on how to enroll in these services in the enclosed *Steps You Can Take to Help Protect Personal Information*.

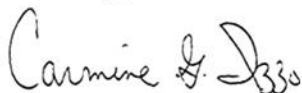

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you may need to provide the following information, depending on whether the request is made online, by phone, or by mail:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

Additional Information
