Re: Notification of a Potential Data Security Incident

Dear Mr. Karberg:

We represent Town of Stowe, Vermont ("Stowe"), 67 Main Street, Stowe, Vermont, 05672 in connection with an incident that may have involved the personal information of one (1) Maryland resident. Stowe is reporting the incident pursuant to MD. CODE ANN., COM. LAW § 14-3504(h). This notice will be supplemented, if necessary, with any new significant facts discovered subsequent to this submission. While Stowe is notifying you of this incident, Stowe does not waive any rights or defenses relating to the incident, this notice, or the applicability of Maryland law on personal jurisdiction.

NATURE OF THE INCIDENT

On August 30, 2022, Stowe identified suspicious activity in one (1) Stowe email account when the account began sending spam emails. Upon learning of the incident, Stowe promptly secured the email account and began an internal investigation. Stowe also engaged a forensic security firm to investigate and confirm the security of its email and computer systems. The forensic investigation recently concluded and determined that an unknown, unauthorized third party accessed five (5) Stowe email accounts from August 29, 2022 to September 7, 2022.

The investigation did not find evidence confirming that the third party actually viewed any personal information in the accounts. Nevertheless, because there was unauthorized access to the email accounts, Stowe reviewed the contents of accounts to determine if they contained any personal information that may have been accessible to the third party. Stowe then looked

for addresses for the individuals whose personal information was contained in the email accounts so that notice could be provided.

NOTICE TO THE MARYLAND RESIDENT

On February 8, 2023, based on the results of a National Change of Address database search, Stowe determined that the personal information contained in the accounts included the name, date of birth, and Social Security number of one (1) Maryland resident. Stowe is mailing the notification letter to the individual today, February 14, 2023. The notification letter will include an offer for twelve (12) months of complimentary credit monitoring and identity theft protection. Enclosed is a copy of the notice that is being sent to the resident via first-class United States mail.

STEPS TAKEN RELATING TO THE INCIDENT

Upon learning of the incident, Stowe promptly contained the incident by securing the email accounts to prevent further access. It also engaged a forensic security firm through counsel to investigate and confirm the security of its email and computer systems. Stowe is undertaking efforts to reduce the risk of a similar incident occurring in the future, including enhancing its technical security measures. Finally, as discussed above, Stowe is notifying the involved resident with an offer for one year of complimentary credit monitoring and identity theft protection.

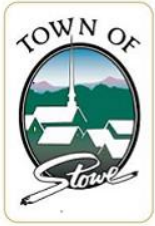

RE: NOTICE OF DATA BREACH

The Town of Stowe, Vermont (“Stowe”) values and respects the privacy of your information, which is why we are writing to advise you of a recent incident that may have involved some of your personal information. We have no reason to believe that your personal information has been misused for the purpose of committing fraud or identity theft. Nonetheless, we are writing to advise you about the incident and to provide you with guidance on what you can do to protect yourself, should you feel it is appropriate to do so.

What Happened? On August 30, 2022, Stowe identified suspicious activity in one (1) Stowe email account. Upon learning of the incident, we promptly secured the email account and began an internal investigation. We also engaged a forensic security firm to investigate and confirm the security of our email and computer systems. The forensic investigation recently concluded and determined that an unknown, unauthorized third party accessed certain Stowe email accounts from August 29, 2022 to September 7, 2022.

What Information Was Involved? We reviewed the contents of the accounts to determine if they contained any personal information. On December 15, 2022, we determined that the accounts contained personal information that included your name, together with your <<Breached elements>>.

What We Are Doing. In addition to the actions described above, we have also taken steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. We are also notifying you of the incident so that you can be aware and take steps to protect yourself. Finally, although we are not aware of any instances of fraud or identity theft resulting from this incident, out of an abundance of caution, we are offering a complimentary one-year membership of Experian IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. **For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary, one-year membership, please see the additional information attached to this letter.**

What You Can Do. While we have no evidence that your personal information has been misused, we encourage you to take advantage of the complimentary credit monitoring included in this letter. Fraud Alerts: You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. Credit and Security Freezes: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze can be placed without any charge and is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
