Re: Data Security Incident

Dear Attorney General Brown:

FisherBroyles, LLP represents HopSkipDrive, located at 360 E 2nd Street, Suite 325, Los Angeles, CA 90012, with respect to a data security incident described in more detail below. While HopSkipDrive's investigation remains ongoing, this **preliminary notice** is being provided to your office out of an abundance of caution and in anticipation that the incident potentially impacted Maryland residents. HopSkipDrive takes the security and privacy of the information in its control seriously and is taking steps to prevent a similar incident from occurring in the future.

## **1. Description of the Incident.**

On or about June 12, 2023, HopSkipDrive received an email communication from an unknown threat actor, claiming to have accessed certain third-party applications utilized by HopSkipDrive (the "Incident").

While HopSkipDrive did not become aware of the Incident until June 12, 2023, based on the evidence currently available, an investigation conducted by third-party forensic specialists determined that unauthorized activity may have occurred as early as March 2023. A data mining exercise is being conducted to identify the potentially impacted individuals and what elements of personally identifiable information may be contained within the potentially affected data for notification purposes. As the data mining exercise remains ongoing, it has not yet been determined whether the sensitive information of any Maryland residents has been impacted as a result of the Incident.

As of this writing, HopSkipDrive has not received any reports of fraud or identity theft related to this matter.

## 2. Number of Maryland residents affected.

As the investigation/data mining remains ongoing, the impacted notice population has not yet been identified. As noted above, we are providing this preliminary notice to your office out of an abundance of caution and in anticipation that the Incident potentially impacted Maryland residents. **Upon completion of the data mining exercise and identification of the potentially impacted population, HopSkipDrive will be issuing notice letters to Maryland residents, if warranted. At that time, HopSkipDrive will also provide supplemental notice to your office with additional details as to the Incident and whether any Maryland residents were potentially affected.**

## 3. Steps taken.

Upon discovery of the Incident, HopSkipDrive reported the Incident to law enforcement and worked with cybersecurity counsel and forensic experts to investigate how the Incident occurred and what information was potentially compromised. HopSkipDrive is committed to ensuring the security of all information in its control and is taking steps to prevent a similar event from occurring in the future, including strengthening its security posture. Additionally, to the extent the investigation determines the Social Security number of Maryland residents were potentially impacted, they will be offered complimentary identity theft and credit monitoring services for twelve (12) months.

Re: Supplemental Notice of a Data Security Incident

Dear Attorney General Brown:

Pierson Ferdinand, LLP represents HopSkipDrive, Inc. (“HopSkipDrive”) located at 360 E 2nd Street, Suite 325, Los Angeles, CA 90012 with respect to a data security incident initially noticed to your office on or about July 27, 2023.<sup>1</sup> HopSkipDrive takes the security and privacy of the information in its control seriously and has taken steps to prevent a similar incident from occurring in the future.

On June 12, 2023, HopSkipDrive received an email communication from an unknown threat actor, claiming to have obtained certain “sensitive information” stored on certain third-party applications used by HopSkipDrive (the “Incident”). HopSkipDrive promptly launched an investigation, engaged experts to assist in assessing what information may have been impacted as a result of the Incident and took steps to mitigate the potential impact to its community. Based on the evidence available, an investigation conducted by third-party forensic specialists determined that unauthorized activity may have occurred between May 31, 2023 and June 10, 2023. Upon identification of the potentially impacted data set, data mining was conducted to identify the potentially impacted individuals and what elements of personally identifiable information may have been affected. Upon completion of the data mining, efforts were then initiated to locate sufficient address information for the potentially impacted population. The investigation and data mining exercise determined that the following elements of personal information of Maryland residents were potentially impacted: names, Social Security numbers, dates of birth, driver's

license numbers, and medical information.<sup>2</sup> We note the potentially affected population was limited to certain individuals who applied to be a HopSkipDrive driver via a third-party application.

### **1. Number of Maryland residents affected.**

HopSkipDrive discovered that the Incident may have impacted two thousand, five hundred and ninety-four (2,594) Maryland residents. While preliminary notification was provided to HopSkipDrive's community on or about July 3, 2023, following the completion of the investigation, and as address information became available, formal notification letters were mailed to potentially impacted individuals on November 14, 2023, December 11, 2023, and January 10, 2024, via First Class Mail. A sample copy of the notification letter is attached as **Exhibit A**.

### **2. Steps taken.**

Upon discovery of the Incident, HopSkipDrive reported the Incident to law enforcement and worked with cybersecurity counsel and forensic experts to investigate how the Incident occurred and what information may have been impacted.

HopSkipDrive is committed to ensuring the security of all information in its control and continually evaluates and modifies its practices to strengthen its security posture. Additionally, the notified Maryland residents were offered complimentary identity theft and credit monitoring services for twelve (12) months.

### **Notice of Data Incident**

HopSkipDrive recently experienced a data security incident which may have affected your personal information. Based on our current review, we have no indication that your personal information has been or will be used inappropriately, in an abundance of caution, we wanted to make you aware of the incident and, the measures we have taken in response, as well as provide details on the steps you can take to help protect your information. We take the protection and proper use of your information seriously and have been working to prevent a similar incident from occurring again in the future.

### **What Happened**

On or about July 25, 2023, HopSkipDrive received an email communication from an unknown threat actor, claiming to have accessed certain third-party applications utilized by HopSkipDrive. We promptly launched an investigation, engaged experts to assist in assessing the scope of the incident and took steps to mitigate the potential impact to our community. Unfortunately, these types of incidents are becoming increasingly common and across sectors, categories, and organizations. We have diligently worked to determine what happened and what information was involved as a result of this incident. A third-party forensic investigation determined the incident occurred between May 31, 2023 and June 10, 2023

### **What Information Was Involved**

The elements of your personal information that may have been impacted may have included, and potentially were not limited to, your: name, mailing address, email address, <<data elements>>. Please note that we have no evidence at this time that any of your personal information has been or will be misused as a result of the incident.

### **What We Are Doing**

We are taking this incident seriously and are committed to strengthening our systems' security to prevent a similar event from occurring again in the future. Additionally, out of an abundance of caution, we have arranged for you to activate, at no cost to you, TransUnion credit monitoring, as well as receive a TransUnion credit report and credit score services at no charge. These services provide you with alerts

for <<service length>> months from the date of enrollment when changes occur to your credit file. With this service, notification will be sent to you the same day that a change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

### **What You Can Do**

To enroll in the complimentary services we are offering you, please visit <https://secure.identityforce.com/benefit/hopskipdrive> and follow the instructions provided. When prompted please provide the following unique code to receive services: <<unique code>>. In order for you to receive the monitoring services described above, you must enroll within ninety (90) days from the date of this letter.

Please note that to activate monitoring services, you will need an internet connection and e-mail account. Additionally, you may be required to provide your name, date of birth, and Social Security number to confirm your identity. Due to privacy laws, we cannot register you directly. Please note that the certain services might not be available for individuals who do not have a credit file with the credit bureaus or an address in the United States (or its territories) and a valid Social Security number. Activating this service will not affect your credit score.

At this time, we are not aware of anyone experiencing fraud as a result of this incident. As data incidents are increasingly common, we encourage you to always remain vigilant, monitor your accounts, and immediately report any suspicious activity or suspected misuse of your personal information. Additionally, we recommend that you review the following pages, which contain important additional information about steps you can take to safeguard your personal information, such as the implementation of fraud alerts and security freezes.

## **Additional Important Information**

### **For residents of all states:**

**Fraud Alerts:** You can place fraud alerts with the three credit bureaus by phone and online with Equifax ([https://assets.equifax.com/assets/personal/Fraud Alert Request Form.pdf](https://assets.equifax.com/assets/personal/Fraud%20Alert%20Request%20Form.pdf)); TransUnion (<https://www.transunion.com/fraud-alerts>); or Experian (<https://www.experian.com/fraud/center.html>). A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. As of September 21, 2018, initial fraud alerts last for one year. Victims of identity theft can also get an extended fraud alert for seven years. The phone numbers for all three credit bureaus are at the bottom of this page.

**Monitoring:** You should always remain vigilant and monitor your accounts for suspicious or unusual activity.

**Security Freeze:** You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze. You may also place a security freeze for children under the age of 16. You may obtain a free security freeze by contacting any one or more of the following national consumer reporting agencies:

### **Implementing an Identity Protection PIN (IP PIN) with the IRS:**

To help protect against a fraudulent tax return being filed under your name, we recommend Implementing an Identity Protection PIN (IP PIN) with the IRS. An IP PIN is a six-digit number that prevents someone else from filing a tax return using your Social Security number or Individual Taxpayer Identification Number. The IP PIN is known only to you and the IRS. It helps the IRS verify your identity when you file your electronic or paper tax return. Even though you may not have a filing requirement, an IP PIN still protects your account.

If you don't already have an IP PIN, you may get an IP PIN as a proactive step to protect yourself from tax-related identity theft. If you want to request an IP PIN, please note: you must pass an identity verification process; and Spouses and dependents are eligible for an IP PIN if they can pass the identity verification process. The fastest way to receive an IP PIN is by using the online Get an IP PIN tool found at: <https://www.irs.gov/identity-theft-fraud-scams/get-an-identity-protection-pin>. If you wish to get an IP PIN and you don't already have an account on IRS.gov, you must register to validate your identity.

Some items to consider when obtaining an IP PIN with the IRS:

- An IP PIN is valid for one calendar year.
- A new IP PIN is generated each year for your account.
- Logging back into the Get an IP PIN tool, will display your current IP PIN.
- An IP PIN must be used when filing any federal tax returns during the year including prior year returns.

**For residents of Hawaii, Michigan, Missouri, North Carolina, Vermont, Virginia, and Wyoming:** It is recommended by state law that you remain vigilant for incidents of fraud and identity theft by reviewing credit card account statements and monitoring your credit report for unauthorized activity.
