Re: Notice of Data Event

To Whom It May Concern:

We represent Comprehensive Auto Resource Company, Inc. ("CARco") located at P.O. Box 1268, Exton, PA 19341, and are writing to notify your office of an incident that may affect the security of certain personal information relating to one (1) Maryland resident. This notice may be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, CARco does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

On March 23, 2023, CARco became aware of suspicious activity related to some of its computer systems. CARco immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. The investigation determined that certain computer systems were subject to unauthorized access between March 20, 2023, to March 23, 2023. CARco began reviewing the contents to the affected systems to determine, what if any, sensitive information was contained within the systems in question. CARco worked diligently to identify individuals who may be impacted, the types of information at issue. As a result of that review, CARco determined that certain information was impacted.

The information that could have been subject to unauthorized access includes name, Social Security number and financial account information.

Notice to Maryland Resident

On or about November 29, 2023, CARco provided written notice of this incident to one (1) Maryland resident. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, CARco moved quickly to investigate and respond to the incident, assess the security of CARco systems, and identify potentially affected individuals. Further, CARco notified federal law enforcement regarding the event. CARco is also working to implement additional safeguards and training to its employees. CARco is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, CARco is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. CARco is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

NOTICE OF <<SECURITY INCIDENT / DATA BREACH>>

Comprehensive Auto Resources Company, Inc. ("CARco") writes to inform you of an incident that may affect the privacy of some of your personal information. The purpose of this letter is to provide details of the incident, our response, and steps you can take to protect your personal information, should you feel it appropriate to do so.

What Happened? On March 23, 2023, CARco became aware of suspicious activity related to some of its computer systems. CARco immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. The investigation determined that certain computer systems were subject to unauthorized access between March 20, 2023, to March 23, 2023. CARco began reviewing the contents to the affected systems to determine, what if any, sensitive information was contained within the systems in question. CARco has worked diligently to identify individuals who may be impacted, the types of information at issue, and the best contact information for those who may be impacted. As a result of that review, CARco determined that certain information related to you may have been impacted.

What Information Was Involved? Our investigation determined that your information was present in the affected systems and it is possible that this information was accessed or acquired by an unauthorized actor. This information includes your name, <<Breached Elements>>. While CARco has no reason to believe that any identity theft or unauthorized use of the affected information has occurred, we are making you aware of this incident in an abundance of caution.

What Are We Doing? CARco takes the confidentiality, privacy, and security of information in our care very seriously. Upon discovery, we immediately commenced an investigation to confirm the nature and scope of the incident. We are also taking steps to implement additional safeguards and review policies and procedures relating to data privacy and security. CARco is also offering you access to complimentary credit monitoring and identity protection services for <<12/24>> months through Experian. These services include fraud consultation and identity theft restoration services. If you wish to activate the credit monitoring and identity protection services, you may follow the instructions in the *Steps You Can Take to Help Protect Your Information*, included here.

What You Can Do. You can enroll in the complimentary credit monitoring services we are offering you. You can also review the enclosed *Steps You Can Take to Help Protect Your Information*. CARco also encourages you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 months.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
