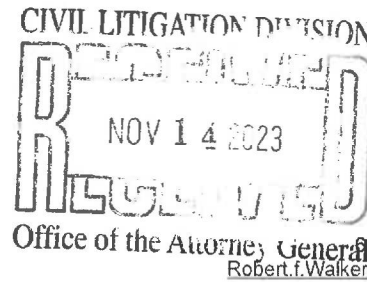

Dear Attorney General Frosh:

We represent Security Instrument Corp. ("SIC") with respect to a potential data security incident described in more detail below. SIC takes the security and privacy of the information in its control seriously, and has taken steps to prevent a similar incident from occurring in the future.

This letter will serve to inform you of the nature of the security breach, the number of Maryland residents that were potentially affected, what information has been compromised, and the steps that SIC is taking to secure the integrity of its systems. We have also enclosed hereto samples of the notifications made to the potentially impacted individuals, which includes an offer of free credit monitoring.

1. Nature of the Security Incident

On September 26, 2023, Security Instrument Corp. ("SIC") experienced a network security incident that involved an unauthorized party gaining access to certain systems within its network environment. Upon detecting the incident, SIC immediately shut off all access to the network and engaged a specialized third-party forensic incident response firm to assist with securing the network environment and investigating the extent of unauthorized activity.

After a careful review of documents and files allegedly exfiltrated by the threat actor, SIC determined that the following information for some employees may have been impacted: first

name, last name, and social security number. Notably, not every individual's Social Security number was exposed.

As of this writing, we have no evidence and have not received any reports of related identity theft since the discovery of the incident.

2. Maryland Residents Notified

Nine (9) Maryland residents were potentially affected by this incident. Individual notification letters were mailed to all impacted individuals on November 7, 2023, by first class mail. A sample copy of the notification letter is included with this letter.

3. Steps Taken

Although SIC is not aware of any evidence of misuse of personal information, SIC has extended to all potentially impacted individuals an offer for free credit monitoring and identity theft protection through CyberScout. This service will include 12 months of credit monitoring, along with a fully managed identity theft recovery service, should the need arise. SIC has changed passwords, strengthened password requirements, and implemented multi-factor authentication. SIC is also conducting appropriate employee retraining to ensure this incident does not occur again.

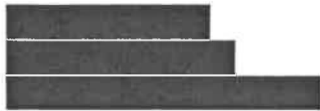

Notice of Data Security Incident

Security Instrument is writing to inform you of a recent data security incident that may have resulted in unauthorized acquisition of your personal information. You are receiving this letter because you are either a former or current employee of Security Instrument. Security Instrument takes your privacy and security seriously. As such, this letter contains details about the incident and resources to help protect your personal information going forward.

What Happened:

On September 26, 2023, Security Instrument experienced a network security incident that involved an unauthorized party gaining access to certain systems within our network environment. Upon detecting the incident, we immediately shut off all access to the network and engaged a specialized third-party forensic incident response firm to assist with securing the network environment and investigating the extent of unauthorized activity. Security Instrument's network has been secured.

Security Instrument found no evidence that your information has been misused. However, the unauthorized third party may have acquired certain personal information as a result of this incident.

What Information Was Involved:

Again, we found no evidence that your information has been specifically misused; however, it is possible that the following personal information could have been acquired by an unauthorized third party: first name, last name, date of birth, and Social Security number. Notably the types of information affected were different for each individual, and not every individual had all of the above listed elements exposed. We maintain this information for administrative, payroll, and human resources purposes.

What We Are Doing:

Data security is among Security Instrument's highest priorities. We have made immediate enhancements to our systems, security and practices. Additionally, we have engaged appropriate experts to assist us in conducting a full review of our security practices and systems to ensure that enhanced security protocols are in place going forward. We are committed to helping those people who may have been impacted by this unfortunate situation.

Additionally, in response to the incident, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for twelve (12) months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

What You Can Do:

To enroll in Credit Monitoring services at no charge, please log on to **<https://secure.identityforce.com/benefit/securityinstrument>** and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED] In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Please keep this letter, as you will need to reference the enrollment code above when calling or enrolling online.

We encourage you to take full advantage of these services. Enclosed you will find additional materials regarding the resources available to you, and the steps you can take to further protect your personal information.

Credit Reports: You may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the three nationwide credit reporting agencies. To order your free credit report, please visit www.annualcreditreport.com, or call toll-free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available at <https://www.consumer.ftc.gov/articles/0155-free-credit-reports>) to: Annual Credit Report Request Service, P.O. Security Freeze: You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well):

- (1) full name, with middle initial and any suffixes;
- (2) Social Security number;
- (3) date of birth;
- (4) current address and any previous addresses for the past five years; and
- (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles.

The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze. Fraud Alerts: You can place fraud alerts with the three credit bureaus by phone and online with:

A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts.
