Re: Notice of Data Event

To Whom It May Concern:

We represent National Experienced Workforce Solutions, Inc. (“NEW Solutions”) located at 3811 North Fairfax Dr., Suite 900, Arlington, VA 22203, and are writing to notify your office of an incident that may affect the security of certain personal information relating to one (1) Maryland resident. By providing this notice, NEW Solutions does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or around March 18, 2024, NEW Solutions became aware that an internal website containing enrollee personal information had become accessible to the public. NEW Solutions immediately launched an investigation, with the assistance of third-party forensic specialists, to confirm the full nature and scope of this issue. The investigation determined that the website inadvertently became publicly available between March 14 – 18, 2024. There is no indication that any malicious activity occurred in relation to the website or any enrollee personal information during the incident. Further, NEW Solutions is not aware of any reports of identity theft or fraud relating to this incident. In response to learning of the issue, NEW Solutions immediately removed public access to the website and limited access to authorized users. NEW Solutions also coordinated with Google to ensure any contents of the website that had been indexed by their search engine be removed. NEW Solutions then conducted a thorough review to determine the extent to which enrollee personal information was potentially impacted.

The information that could have been subject to unauthorized access includes Social Security Number, medical information, and name.

Notice to Maryland Resident

On or about May 21, 2024, NEW Solutions provided written notice of this incident to one (1) Maryland resident. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, NEW Solutions moved quickly to investigate and respond to the incident, assess the security of NEW Solutions' systems, and identify potentially affected individuals. NEW Solutions is also working to implement additional safeguards and training to its employees. NEW Solutions is providing access to credit monitoring services for 24-months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, NEW Solutions is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. NEW Solutions is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Dear Sample A. Sample:

The National Experienced Workforce Solutions, Inc. (“NEW Solutions”) is writing to notify you of an incident that may affect the privacy of some of your information. Although we have no indication of any identity theft or fraud occurring in relation to this event, we are notifying you in an abundance of caution. This letter provides details of the incident, our response, and resources available to you to help protect your information from possible misuse, should you feel it is appropriate to do so.

What Happened? On or around March 18, 2024, NEW Solutions became aware that an internal website containing enrollee personal information had become accessible to the public. We immediately launched an investigation, with the assistance of third-party forensic specialists, to confirm the full nature and scope of this issue. The investigation determined that the website inadvertently became publicly available between March 14 - 18, 2024. There is no indication that any malicious activity occurred in relation to the website or any enrollee personal information during the incident. Further, NEW Solutions is not aware of any reports of identity theft or fraud relating to this incident. In response to learning of the issue, we immediately removed public access to the website and limited access to authorized users. We also coordinated with Google to ensure any contents of the website that had been indexed by their search engine be removed. We then conducted a thorough review to determine the extent to which enrollee personal information was potentially impacted.

What Information Was Involved? Our investigation determined the following types of information related to you may have been impacted: [Extra2] and name. At this time, we have no indication of identity theft or fraud occurring in relation to this incident.

What We Are Doing. Data privacy and security are among NEW Solutions’ highest priorities, and there are extensive measures in place to protect the information in our care. Upon discovery, we promptly commenced an investigation with the assistance of third-party computer forensic specialists to confirm the nature and scope of this incident. This investigation and response included confirming the security of our systems, reviewing the contents of relevant data for sensitive information, and notifying potentially impacted individuals. As part of our ongoing commitment to the privacy of information in our care, we continue to review our policies, procedures and processes related to the storage and access of personal information to reduce the likelihood of a similar future event. We will also notify applicable regulatory authorities where necessary.

As an added precaution, we are also offering 24-months of complimentary access to credit monitoring services through Experian. Individuals who wish to receive these services must enroll by following the attached enrollment instructions as we are not able to enroll you on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors.

You may also review the information contained in the attached *Steps You Can Take to Help Protect Personal Information*. There you will also find more information on the complimentary credit monitoring services we are making available to you.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.
