Re: Notice of Data Event

To Whom It May Concern:

We represent Jordan Wealth Management (“JWM”) located at 3635 Genesee Street Buffalo, New York 14225, and are writing to notify your office of an incident that may affect the security of certain personal information relating to one (1) Maryland resident. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, JWM does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or around January 25, 2024, JWM became aware of unusual activity involving an employee’s email account. JWM investigated the activity and on or around February 20th the investigation determined the account was accessed by an unknown individual. Although the account was configured with multifactor authentication, the initial activity believed to have caused the access was the employee’s interaction with a malicious link from a phishing email. The account was reviewed for sensitive information and on or around April 18, 2024, the review was completed. Since then, JWM worked to validate the data and review and confirm necessary address information to prepare for notification.

The review determined the following types of personal information relating to individuals was present in the email account: name; Social Security number.

Notice to Maryland Resident

On or about May 31, 2024, JWM provided written notice of this incident to one (1) Maryland residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the activity, JWM moved quickly to investigate and respond to the incident, including assessing the security of JWM's email environment, and identifying potentially affected individuals. JWM notified federal law enforcement of this event. JWM is also working to implement additional safeguards and training to its employees. JWM is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

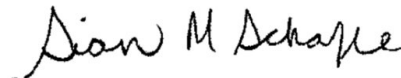
Additionally, JWM is providing individuals with guidance on how to better protect against identity theft and fraud. JWM is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

JWM is providing written notice of this incident to relevant state regulators, as necessary.

NOTICE OF DATA BREACH

Jordan Wealth Management is writing to notify you of an incident at Jordan Wealth Management. This notice provides you with information about the incident, our response, and resources available to you to help better protect your information, should you feel appropriate to do so.

What Happened? On or around January 25, 2024, we became aware of unusual activity involving an employee's email account. We investigated the activity and the investigation determined the account was accessed by an unknown individual. The account was reviewed for sensitive information and on or around April 18, 2024, the review was completed. Since then, we worked to review and confirm necessary address information to prepare for notification.

What Information Was Involved? The review determined the following types of personal information relating to you were present in the email account: name; [Extra2].

What We Are Doing. We take this incident and the security of personal information in our care seriously. Upon discovering the unusual activity, we took steps to secure the employee email account, assess the security of the email environment, and investigate the activity. As part of our ongoing commitment to the privacy of information in our care, we are reviewing and enhancing our existing policies and procedures. As an added precaution, we are offering you access to credit monitoring services for [Extra4] months at no cost to you. More information about these services is attached in the Steps You Can Take to Protect Personal Information.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 to 24 months. You may also review the information contained in the attached Steps You Can Take to Protect Personal Information. Further, you may enroll in the offered complimentary monitoring services. Although we are making these services available to you, due to privacy restrictions, we are unable to enroll you directly.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
