Dear Attorney General Brown:

Wilson Elser Moskowitz Edelman and Dicker LLP (“Wilson Elser”) represents Consulting Radiologists LTD. (“CRL”), a healthcare company located at 7595 Anagram Drive, Eden Prairie, MN 55344, with respect to a recent cybersecurity incident that was first discovered by CRL on February 12, 2024, (hereinafter, the “Incident”). CRL takes the security and privacy of the information in its control very seriously, and has taken steps to prevent a similar incident from occurring in the future.

This letter will serve to inform you of the nature of the Incident, what information may have been compromised, the number of Maryland residents being notified, and the steps that CRL has taken in response to the Incident. We have also included with this letter a sample of the notification made to the potentially impacted individuals, which includes an offer of free credit monitoring services. By providing this notice, CRL does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

1. Nature of the Incident

On February 12, 2024, CRL detected suspicious activity in its network environment. Upon discovery of this incident, CRL promptly took steps to secure its network and engaged a specialized cybersecurity firm to investigate the nature and scope of the incident. As a result of the investigation, CRL learned that an unauthorized actor accessed certain files and data stored within our network.

Upon learning this, CRL began a time-consuming and detailed reconstruction and review of the data stored on the server at the time of this incident to understand whose information was affected. On April 17, 2024, CRL identified persons whose sensitive data was included within the impacted data. At this time, we have no evidence any of the information has been misused by a third party. The following types of information may have been impacted: Name, date of birth, address, health insurance information, and medical information as well as Social Security

number and driver's license number for a small subset of persons. The type of information at issue varies for each person.

2. Number of Maryland residents affected.

A total of 95 Maryland residents may have been potentially affected by this incident. Notification letters to these individuals began to be mailed on June 14, 2024. A sample copy of the notification letter is included with this letter under **Exhibit A**.

3. Steps taken in response to the Incident.

CRL is committed to ensuring the security and privacy of all personal information in its control and is taking steps to prevent a similar incident from occurring in the future. Upon discovery of the Incident, CRL moved quickly to investigate and respond to the Incident, assessed the security of its systems, and notified the potentially affected individuals. Specifically, CRL engaged a specialized cybersecurity firm to conduct a forensic investigation to determine the nature and scope of the Incident. CRL informed our law firm and began identifying the potentially affected individuals in preparation for notice.

Although CRL is not aware of any actual or attempted misuse of the affected personal information, CRL offered 12 months of complimentary credit monitoring and identity theft restoration services. As part of its ongoing commitment to the security of information, CRL is reviewing and enhancing its existing policies and procedures related to data privacy to reduce the likelihood of a similar future event.

At this time, we have no evidence any of the information has been misused by a third party, but because information related to you was disclosed, we are notifying you out of full transparency.

What Information Was Involved?

The following data was potentially accessed and acquired by a person not authorized to view them: Name, Address, date of birth, Social Security number, Health Insurance information, Medical information.

What Are We Doing?

Data security is one of our highest priorities. Upon detecting this incident, we moved quickly to initiate an investigation, which included retaining a leading forensic investigation firm who assisted in conducting an investigation and confirming the security of our network environment. We also deployed additional monitoring tools and will continue to enhance the security of our systems. We take the protection and proper use of personal information very seriously.

As part of our ongoing commitment to information privacy and the security of information, we are notifying you of this incident, and we are providing you with access to **Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score** services at no charge. These services provide you with alerts for twelve months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

Dear Attorney General Brown:

Wilson Elser Moskowitz Edelman and Dicker LLP (“Wilson Elser”) represents Consulting Radiologists LTD. (“CRL”), with respect to a recent cybersecurity incident that was first discovered by CRL on February 12, 2024, (hereinafter, the “Incident”). CRL takes the security and privacy of the information in its control very seriously, and has taken steps to prevent a similar incident from occurring in the future.

This letter is supplemental to the CRL’s June 14, 2024, Incident notification letter. This letter will serve to update you of the nature of the Incident, what information may have been compromised, the number of Maryland residents being notified, and the steps the CRL has taken in response to the Incident. We have also included with this letter a sample of the notification made to the potentially impacted individuals, which includes an offer of free credit monitoring services to those persons whose Social Security numbers were potentially impacted. By providing this notice, CRL does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

1. Nature of the Incident

On February 12, 2024, CRL detected suspicious activity in its network environment. Upon discovery of this incident, CRL promptly took steps to secure its network and engaged a specialized cybersecurity firm to investigate the nature and scope of the incident. As a result of the investigation, CRL learned that an unauthorized actor accessed certain files and data stored within our network.

Upon learning this, CRL began a time-consuming and detailed reconstruction and review of the data stored on the server at the time of this incident to understand whose information was affected. On April 17, 2024, CRL identified persons whose sensitive data was included within the impacted data. At this time, we have no evidence any of the information has been misused by a third party. The following types of information may have been impacted: Name, date of birth, address, health insurance information, and medical information as well as Social Security number and driver’s

license number for a small subset of persons. The type of information at issue varies for each person.

2. Number of Maryland residents affected.

A new total of 108 Maryland residents may have been potentially affected by this incident. Notification letters to these individuals began to be mailed on August 27, 2024. A sample copy of the notification letter is included with this letter under **Exhibit A**.

3. Steps taken in response to the Incident.

CRL is committed to ensuring the security and privacy of all personal information in its control and is taking steps to prevent a similar incident from occurring in the future. Upon discovery of the Incident, CRL moved quickly to investigate and respond to the Incident, assessed the security of its systems, and notified the potentially affected individuals. Specifically, CRL engaged a specialized cybersecurity firm to conduct a forensic investigation to determine the nature and scope of the Incident. CRL informed our law firm and began identifying the potentially affected individuals in preparation for notice.

Although CRL is not aware of any actual or attempted misuse of the affected personal information, CRL offered 12 months of complimentary credit monitoring and identity theft restoration services to those persons whose Social Security numbers were potentially impacted. As part of its ongoing commitment to the security of information, CRL is reviewing and enhancing its existing policies and procedures related to data privacy to reduce the likelihood of a similar future event.
