Re: Notice of Data Breach Involving Consilium Staffing, Inc.

Dear Attorney General Brown:

Wilson Elser Moskowitz Edelman and Dicker LLP (“Wilson Elser”) represents Consilium Staffing. (“Consilium”), is a locum tenens company that connects healthcare providers with potential medical staff at 6363 State HWY 161 Ste 800, Irving, Texas 75038 with respect to a recent cybersecurity incident that was first discovered by Consilium on October 24, 2024 (hereinafter, the “Incident”). Consilium takes the security and privacy of the information in its control very seriously, and has taken steps to prevent a similar incident from occurring in the future.

This letter will serve to inform you of the nature of the Incident, what information may have been compromised, the number of Maryland residents being notified, and the steps that Consilium has taken in response to the Incident. We have also enclosed hereto a sample of the notification made to the potentially impacted individuals, which includes an offer of free credit monitoring services.

1. Nature of the Incident

On October 24, 2023, Consilium detected suspicious activity on its network (“Incident”). Upon discovering the Incident, Consilium engaged a specialized cybersecurity firm to conduct a forensic investigation to determine the extent and root cause of the Incident. The forensic investigation was completed on February 7, 2024. Thereafter, Consilium conducted an in-depth review of all relevant data files for the purpose of identifying all individuals whose personal information may have been exposed as a result of the Incident. Consilium’s manual review of the data files was completed in April 2024 and a notice list of affected individuals was finalized on April 26, 2024. Consilium proceeded to engage a third-party vendor to assist with mailing notices, setting up a call center, offering credit monitoring and identity theft protection services, and updating missing addresses on June 10, 2024. As of this writing, Consilium has not received any reports of related identity theft since the date of the incident October 24, 2023 to present).

Based on its investigation, the personal information that may have been compromised included: first and last name; address; date of birth; Social Security number; driver's license number or state-issued identification.

2. Number of Maryland residents affected.

A total of five (5) Maryland residents may have been potentially affected by this incident. Notification letters to these individuals were mailed on July 15, 2024, by first class mail. A sample copy of the notification letter is included with this letter as **Exhibit A**.

3. Steps taken in response to the Incident.

Data privacy and security is among Consilium's highest priorities, and we are committed to doing everything we can to protect the privacy and security of the personal information in our care. Upon discovery of the Incident, Consilium moved quickly to investigate and respond to the Incident and assessed the security of its systems. Specifically, Consilium engaged a specialized cybersecurity firm and IT personnel to conduct a forensic investigation to determine the nature and scope of the incident.

Upon detecting this incident, we moved quickly to initiate an investigation, which included retaining a leading forensic investigation firm who assisted in conducting an investigation and confirming the security of our network environment. Consilium also deployed additional monitoring tools and will continue to enhance the security of our systems. We take the protection and proper use of personal information very seriously and will continue to take steps to mitigate the risk of future harm.

Consilium offered 12 months of complimentary credit monitoring and identity theft restoration services through Cyberscout, a TransUnion company specializing in fraud assistance and remediation services, to all affected individuals to help protect their identity. Additionally, Consilium provided guidance on how to better protect against identity theft and fraud, including providing information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and the contact details for the Federal Trade Commission.

Re: Notice of Security Incident

Dear [REDACTED]:

Consilium Staffing, Inc. (“Consilium”) is writing to inform you of a data security incident involving your sensitive information. While we are unaware of any fraudulent misuse of your data at this time, we are providing you with details about the incident, steps we are taking in response, and resources available to help you protect against the potential misuse of your data. Please be assured Consilium takes the protection and proper use of your data very seriously.

What Happened?

On October 24, 2023, Consilium detected suspicious activity on its network (“Incident”). Upon discovering the Incident, Consilium engaged a specialized cybersecurity firm to conduct a forensic investigation to determine the extent and root cause of the Incident. The forensic investigation was completed on February 7, 2024. Thereafter, Consilium conducted an in-depth review of all relevant data files for the purpose of identifying all individuals whose personal information may have been exposed as a result of the Incident. Consilium’s manual review of the data files was completed in April 2024 and a notice list of affected individuals was finalized on April 26, 2024. What Information Was Involved?

Although Consilium has no evidence that any sensitive information has been misused by third parties as a result of this incident, we are notifying you out of an abundance of caution and for purposes of full transparency. Based on the investigation, the following data was potentially accessed and acquired by a person not authorized to view them: Social Security number and date of birth.

We would like to reassure you that we have taken all efforts possible to mitigate any further exposure of your personal information, and we are committed to supporting you.

What We Are Doing?

Data security is one of our highest priorities. Upon detecting this incident, we moved quickly to initiate an investigation, which included retaining a leading forensic investigation firm who assisted in conducting an investigation and confirming the security of our network environment. We also deployed additional monitoring tools and will continue to enhance the security of our systems. We take the protection and proper use of personal information very seriously and will continue to take steps to mitigate the risk of future harm.

As part of our ongoing commitment to information privacy and the security of information we are notifying you of this incident, and we are providing you with access to **Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score** services at no charge. These services provide you with alerts for twelve months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

What You Can Do

We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious or unauthorized activity. Additionally, security experts suggest that you contact your financial institution and all major credit bureaus to inform them of such a breach and then take whatever steps are recommended to protect your interests, including the possible placement of a fraud alert on your credit file. Please review the enclosed *Additional Information* to learn more about how to protect against the possibility of information misuse.

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED] Please note that the code is case-sensitive and will need to be entered as it appears.

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Once enrolled you will have twelve months of monitoring services. At the end of twelve months, the services will be deactivated. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

For More Information

Representatives are available for 90 days from the date of this letter, to assist you with questions regarding this incident, between the hours of 8:00 a.m. to 8:00 p.m. Eastern time, Monday through Friday, excluding holidays. Please call the help line 1-800-405-6108 and supply the fraud specialist with the unique code listed above. The call center representatives have been fully versed in the incident and can answer questions or concerns you may have regarding the protection of your personal information.

We would like to reiterate that, at this time, there is no evidence that your information was misused. However, we encourage you to take full advantage of the services offered.

At Consilium, we take our responsibility to protect your personal information very seriously. We apologize for any inconvenience this may cause.

Additional Information

Credit Reports: You may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the three nationwide credit reporting agencies. To order your free credit report, please visit www.annualcreditreport.com, or call toll-free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available at <https://www.consumer.ftc.gov/articles/0155-free-credit-reports>) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281.

Security Freeze: You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze. You may also place a security freeze for children under the age of 16. You may obtain a free security freeze by contacting any one or more of the following national consumer reporting agencies:

Fraud Alerts: You can place fraud alerts with the three credit bureaus by phone and online with:

- ◆ Equifax (https://assets.equifax.com/assets/personal/Fraud_Alert_Request_Form.pdf);
- ◆ TransUnion (<https://www.transunion.com/fraud-alerts>); or
- ◆ Experian (<https://www.experian.com/fraud/center.html>).

A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. As of September 21, 2018, initial fraud alerts last for one year. Victims of identity theft can also get an extended fraud alert for seven years. The phone numbers for all three credit bureaus are at the bottom of this page.

Monitoring: You should always remain vigilant and monitor your accounts for suspicious or unusual activity.

File Police Report: You have the right to file or obtain a police report if you experience identity fraud. Please note that in order to file a crime report or incident report with law enforcement for identity theft, you will likely need to provide proof that you have been a victim. A police report is often required to dispute fraudulent items. You can generally report suspected incidents of identity theft to local law enforcement or to the Attorney General.



FTC and Attorneys General: You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General. The Federal Trade Commission can be reached at: 600 Pennsylvania Avenue NW, Washington, DC 20580, www.identitytheft.gov, 1-877-ID-THEFT (1-877-438-4338), TTY: 1-866-653-4261. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. You have the right to file a police report if you ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, you will likely need to provide some proof that you have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit “prescreened” offers of credit and insurance you get based on information in your credit report; and you may seek damages from violators. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
