Re: Notice of Data Security Incident

Dear Attorney General Brown:

Constangy, Brooks, Smith & Prophete LLP (“Constangy”) represents the Association of Maryland Pilots (“Maryland Pilots”), a state-codified organization in Baltimore, Maryland, in connection with the data security incident described in greater detail below. The purpose of this letter is to notify you of the incident in accordance with Maryland’s data breach notification statute.

1. Nature of the Security Incident

On April 10, 2024, Maryland Pilots became aware of unusual activity related to its network. In response, Maryland Pilots took immediate steps to secure its digital environment and promptly launched an investigation. The investigation conducted by the third-party cybersecurity experts determined that an unknown actor accessed and acquired certain data without authorization.

On June 17, 2024 Maryland Pilots confirmed that certain personal information may have been impacted and then took steps to effectuate notification to potentially impacted individuals as quickly as possible. Please note that there is currently no evidence of fraud or misuse of any of the data, only evidence that data was accessed or acquired without authorization.

2. Number of Affected Maryland Residents & Information Involved

The incident involved personal information for three hundred sixty-six (366) Maryland residents. The information involved in the incident for the affected Maryland residents may have included name and

Social Security number, driver's license, state identification number, payment card number, payment card access information, email with login/password, financial account number with access information, and medical information.

3. Notification to the Affected Individuals

On July 22, 2024, a notification letter was sent to the affected Maryland residents by USPS First Class Mail. The notification letter provides resources and steps these individuals can take to help protect their information. The notification letter also offers the individuals the opportunity to enroll in 12 months of complimentary identity protection services, including credit monitoring, and identity remediation services, as well as access to a call center, should the individuals have questions about the incident. A sample notification letter sent to the impacted individuals is included with this correspondence.

4. Steps Taken Relating to the Incident

In response to the incident, Maryland Pilots retained cybersecurity experts and launched a forensics investigation to determine the source and scope of the compromise. Maryland Pilots also implemented additional security measures to further harden its email environment in an effort to prevent a similar event from occurring in the future.

Finally, Maryland Pilots is notifying the affected individuals and providing them with steps they can take to protect their personal information as discussed above. Maryland Pilots has also established a toll-free call center through IDX, a leader in risk mitigation and response, to answer any questions about the incident and address related concerns.

Re: Notice of Data Security Incident

The Association of Maryland Pilots (“Maryland Pilots”) is writing to inform you of a data security incident that may have involved your personal information. Please read this letter carefully as it contains details about the incident and resources you can utilize to protect your information, including instructions for enrolling in complimentary credit monitoring and identity theft protection services.

What Happened? On April 10, 2024, Maryland Pilots discovered unusual activity associated with an employee’s email account. We immediately engaged cybersecurity specialists to assist with our investigation to determine the nature and scope of the incident. The investigation determined that an unknown actor acquired certain data without authorization. We then conducted a comprehensive review of the affected data to determine whether personal information may have been involved. After a thorough review of the impacted data, on June 17, 2024, it was determined that some of your personal information was present in the impacted data set. We then took steps to notify you of the incident as quickly as possible.

What Information was Involved? The information potentially involved may include your name, <<Variable 2>> <<Variable 3>>.

What We Are Doing. As soon as we discovered the incident, we took the steps described above. We also implemented additional measures to reduce the risk of a similar incident occurring in the future.

We are offering the opportunity to enroll in complimentary identity protection services through IDX, an identity protection and assistance expert. These services include 12 months of credit monitoring and CyberScan (dark web) monitoring, a \$1,000,000 insurance reimbursement policy, and fully managed identity theft recovery services. With this protection, IDX will help you resolve issues if your identity is compromised.

What You Can Do. You can enroll in the complementary services offered to you through IDX identity protection services by calling 1-800-939-4170 or going to <https://app.idx.us/account-creation/protect> and using the Enrollment Code provided above. IDX representatives are available Monday through Friday from XXXX Time. You will need to reference the enrollment code in this letter when calling or enrolling online, so please do not discard this letter. Please note the deadline to enroll is <<Date>>.

STEPS YOU CAN TAKE TO PROTECT YOUR INFORMATION

Review Your Account Statements and Notify Law Enforcement of Suspicious Activity: As a precautionary measure, we recommend that you remain vigilant by reviewing your account statements and credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained. You also should promptly report any fraudulent activity or any suspected incidence of identity theft to proper law enforcement authorities, your state attorney general, and/or the Federal Trade Commission (FTC).

Request a Copy of Your Credit Report: You may obtain a free copy of your credit report from each of the three major credit reporting agencies once every 12 months by visiting <https://www.annualcreditreport.com>, calling toll-free 1-877-322-8228, or by completing an Annual Credit Report Request Form and mailing it to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348. You also can contact one of the following three national credit reporting agencies:

Place a Fraud Alert: You may want to consider placing a fraud alert on your credit report. An initial fraud alert is free and will stay on your credit file for at least one year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any accounts in your name. To place a fraud alert on your credit report, contact any of the three credit reporting agencies identified above. Additional information is available at <https://www.annualcreditreport.com>.

Put a Security Freeze: You have the right to put a security freeze on your credit file for up to one year at no cost. This will prevent new credit from being opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A security freeze is designed to prevent potential creditors from accessing your credit report without your consent. As a result, using a security freeze may interfere with or delay your ability to obtain credit. You must separately place a security freeze on your credit file with each credit reporting agency. In order to place a security freeze, you may be required to provide the consumer reporting agency with information that identifies you, including your full name, Social Security Number, date of birth, current and previous addresses, a copy of your state-issued identification card, and a recent utility bill, bank statement or insurance statement.

Additional Free Resources: You can obtain information from the consumer reporting agencies, the FTC, or from your respective state Attorney General about fraud alerts, security freezes, and steps you can take toward preventing identity theft. You may report suspected identity theft to local law enforcement, including to the FTC or to the Attorney General in your state.
