Dear Attorney General:

We are writing on behalf of Florida Memorial University (“FMU”) with respect to a potential data security incident described in more detail below. FMU takes the security and privacy of the information in its control seriously, and has taken steps to prevent a similar incident from occurring in the future.

This letter will serve to inform you of the nature of the security incident, the number of Maryland residents that were potentially affected, what information has been compromised, and the steps that FMU is taking to secure the integrity of its systems. We have also enclosed hereto samples of the notifications made to the potentially impacted individuals, which includes an offer of free credit monitoring.

1. Nature of the Security Incident

On March 9, 2024, FMU was alerted of a network security incident involving an unauthorized party gaining access to its systems. FMU shut off all access to the network and engaged a specialized third-party forensic incident response firm to assist with securing the network environment and investigating the extent of unauthorized activity.

The forensic investigation determined that the unauthorized third party acquired data as a result of this incident. FMU engaged a data mining vendor to identify any personally identifiable information that potentially compromised. Data mining efforts concluded on June 27, 2024.

2. Information Potentially Impacted

The following personal information was potentially acquired: first name, last name, driver's license or state identification number, Social Security number, Taxpayer Identification number, passport number, health insurance number. Notably, the types of information affected were different for each individual, and not every individual had all the above listed elements exposed.

3. Maryland Residents Notified

FMU has identified a total of eighty-eight (88) Maryland residents potentially affected by this security incident. Notification letters were mailed to those potentially impacted individuals on July 29, 2024, by first class mail. A sample copy of the notification letter is included with this letter.

4. Steps Taken

Although FMU is not aware of any evidence of misuse of personal information, FMU has extended to the potentially impacted individuals an offer for free credit monitoring and identity theft protection through TransUnion. This service will include 12 months of credit monitoring, along with a fully managed identity theft recovery service, should the need arise. Please refer to the sample notification letter enclosed herein for instructions provided to consumers as to how to use such services. FMU has also provided notice to the consumer reporting agencies. Finally, FMU has changed passwords, strengthened password requirements, and implemented stricter multi-factor authentication requirements.

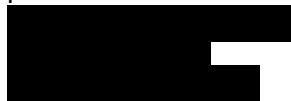

Notice of Data Breach

Dear [REDACTED],

Florida Memorial University (“FMU”) is writing to inform you of an incident that may have exposed your personal information. We take the security of your personal information seriously and want you to know what happened, what data may have been affected, and what you can do to help protect yourself.

What Happened and What Information was Involved:

FMU detected an incident in which an unauthorized third party accessed some of its systems on March 9, 2024. Upon detecting the incident, FMU took the steps necessary to address the event which included immediately shutting off all access to the network and engaging a specialized third-party forensic incident response firm to assist with securing the network environment and investigating the extent of unauthorized activity.

FMU has found no evidence that your information has been misused. However, the forensic investigation determined that the unauthorized third party may have acquired certain information as a result of this incident. After extensive electronic discovery, which concluded on June 27, 2024, we determined an unauthorized third party may have acquired the following personal information: your first and last name, Date of Birth and Social Security Number.

As of this writing, we have not received any reports of misuse of information and/or related identity theft since the date the incident was discovered (March 9, 2024, to present).

What We Are Doing:

Data security is among FMU’s highest priorities, and we are committed to doing everything we can to protect the privacy and security of the personal information in our care. Upon detecting this incident we moved quickly to initiate a response, which included conducting an investigation with the assistance of IT specialists and confirming the security of our network environment. As a result of this incident, we are reviewing technical safeguards and looking into enhancements to prevent a similar incident.

Additionally, **although we have no indication at this time of any misuse of your information**, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for twelve (12) months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by TransUnion, a company specializing in fraud assistance and remediation services.

What You Can Do:

To enroll in Credit Monitoring services at no charge, please log on to **<https://www.mytrueidentity.com>** and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED]. In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

We encourage you to take full advantage of these services. Enclosed you will find additional materials regarding the resources available to you, and the steps you can take to further protect your personal information.

Representatives are aware of the incident at FMU and can answer questions or concerns you may have regarding protection of your personal information. Please call 1-833-531-2069, Monday through Friday, 8:00 am - 8:00 pm Eastern Time for assistance or for any additional questions you may have, excluding holidays.

FMU values the security of the personal data that we maintain, and understand the frustration, concern, and inconvenience that this incident may have caused.

Additional Information

Credit Reports: You may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the three nationwide credit reporting agencies. To order your free credit report, please visit www.annualcreditreport.com, or call toll-free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available at <https://www.consumer.ftc.gov/articles/0155-free-credit-reports>) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281.

Security Freeze: You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles.

The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze. You may also place a security freeze for children under the age of 16. You may obtain a free security freeze by contacting any one or more of the following national consumer reporting agencies:

Fraud Alerts: You can place fraud alerts with the three credit bureaus by phone and online with:

- Equifax (https://assets.equifax.com/assets/personal/Fraud_Alert_Request_Form.pdf);
- TransUnion (<https://www.transunion.com/fraud-alerts>); or
- Experian (<https://www.experian.com/fraud/center.html>).

A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. As of September 21, 2018, initial fraud alerts last for one year. Victims of identity theft can also get an extended fraud alert for seven years. The phone numbers for all three credit bureaus are listed above.

Monitoring: You should always remain vigilant and monitor your accounts for suspicious or unusual activity.

File Police Report: You have the right to file or obtain a police report if you experience identity fraud. Please note that in order to file a crime report or incident report with law enforcement for identity theft, you will likely need to provide proof that you have been a victim. A police report is often required to dispute fraudulent items. You can generally report suspected incidents of identity theft to local law enforcement or to the Attorney General.

FTC and Attorneys General: You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General. For New Mexico residents, you have rights pursuant to the Fair Credit Reporting Act, such as the right to be told if information in your credit file has been used against you, the right to know what is in your credit file, the right to ask for your credit score, and the right to dispute incomplete or inaccurate information. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit “prescreened” offers of credit and insurance you get based on information in your credit report; and you may seek damages from violators. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
