**Re: Legal Notice of Information Security Incident**

Dear Sir or Madam:

I am writing on behalf of my client, Fiskars Group ("Fiskars"), to notify you of a cybersecurity incident.

On April 26, 2024, Fiskars discovered unauthorized activity on Fiskars' network. Fiskars launched an investigation to assess the nature and scope of the activity, and third-party cybersecurity experts were engaged to assist. Fiskars also notified law enforcement. The investigation determined that an unauthorized actor accessed certain Fiskars systems and may have obtained certain files between approximately March 31, 2024 and April 8, 2024. Fiskars then conducted a robust review of the files to identify individuals whose personal information may have been contained in the files.

On October 15, 2024, Fiskars completed its review of the data and identified personal information belonging to certain of Fiskars' current and former employees and their dependents along with current and former vendors, including names and Social Security numbers of nine (9) Maryland residents.

Today, November 6, 2024, Fiskars will begin mailing notification letters to the nine (9) Maryland residents. A sample copy of the notification letter is attached. Fiskars will also be offering 24 months of complimentary credit monitoring and fraud protection services to these individuals. Fiskars is also providing a telephone number for the individuals to call with any questions regarding the incident.

To help prevent a similar type of incident from occurring in the future, Fiskars has implemented, and continues to evaluate, additional security measures designed to enhance the security of its systems and data.

Fiskars Group (Fiskars) takes the privacy and security of personal information seriously. As such, we are writing to inform you of a cybersecurity incident that we recently experienced and which may have involved some of your personal information. This letter is to inform you of this incident, the steps we are taking in response, and the steps that you may consider to help protect your information.

### What Happened?

On April 26, 2024, we discovered unauthorized activity on Fiskars' network. Fiskars immediately began an investigation to assess the nature and scope of the activity. Fiskars engaged third-party cybersecurity experts, and we notified law enforcement. The investigation found that an unauthorized actor accessed certain Fiskars systems and obtained certain files between approximately March 31, 2024 and April 8, 2024. Fiskars then conducted a robust review of the files to identify individuals whose personal information may have been contained in the files.

### What Information Was Involved?

On October 15, 2024, we completed our review and determined that some of your personal information was contained in the files, including your name and Social Security number.

To help prevent a similar occurrence in the future, we have implemented, and continue to implement, numerous measures designed to further enhance the security of our systems and data.
