***RE: Supplemental Security Breach Notification***

To Whom It May Concern:

We continue to serve as counsel for Saratoga Harness Racing, Inc. ("SHR"), located at 342 Jefferson Street, Saratoga Springs, NY 12866. We write to supplement a previous notification regarding a data security incident that we provided to the Maryland Attorney General on December 30, 2024. By providing this notice, SHR does not waive any rights or defenses under Maryland law, including the data breach notification statute.

As previously reported to the Maryland Attorney general on December 30, 2024, on November 1, 2024, SHR experienced a network disruption that limited its ability to access certain files and systems on its network and immediately began an investigation with the assistance of third-party specialists. The investigation determined that an unknown third-party potentially accessed certain files on SHR's network without authorization between October 31 and November 1, 2024.

Therefore, SHR began a thorough review of the files at issue to determine the type of information contained therein and to whom the information related. During this review, SHR determined that the files at issue contained information relating to four (4) residents of Maryland and notified these individuals on December 30, 2024 via First Class U.S. mail. As the SHR review of the files at issue has remained ongoing, SHR determined on January 17, 2025, that the files at issue also contained the names and Social Security numbers and/or driver's license numbers of an additional 13 residents of Maryland, for a total of 17 residents of Maryland potentially impacted by this incident. The additional 13 residents of Maryland were notified of this incident via First Class U.S. mail on January 31, 2025.

A copy of the January 31, 2025 notice to individuals believed to be residents of Maryland is attached as ***Exhibit A***. SHR has no reason to believe any information has been misused because of this incident. However, in an abundance of caution, SHR has offered all potentially impacted residents of Maryland complimentary access to 12 months of credit monitoring and identity protection services.

In response to this incident, SHR notified law enforcement and engaged outside specialists to conduct a thorough forensic investigation. SHR is also reviewing its policies and procedures related to data protection and minimization and has taken additional steps to further enhance its network security and help decrease the chance of a similar incident occurring in the future.

To Whom It May Concern:

We serve as counsel for Saratoga Harness Racing, Inc. ("SHR"), located at 342 Jefferson Street, Saratoga Springs, NY 12866. We write to provide notification of a recent data security incident. By providing this notice, SHR does not waive any rights or defenses under Maryland law, including the data breach notification statute.

On November 1, 2024, SHR experienced a network disruption that limited its ability to access certain files and systems on its network and immediately began an investigation with the assistance of third-party specialists. The investigation determined that an unknown third-party potentially accessed certain files on SHR's network without authorization between October 31 and November 1, 2024.

Therefore, SHR began a thorough review of the files at issue to determine the type of information contained therein and to whom the information related. While this review is ongoing, SHR has determined that the potentially impacted information included the names of four Maryland residents in combination with Social Security number and/or driver's license number.

SHR notified potentially impacted individuals of this incident via First Class mail on December 30, 2024. A copy of the notice is attached as ***Exhibit A***. SHR has no reason to believe any information has been misused because of this incident. However, in an abundance of caution, SHR is offering the potentially impacted residents of Maryland complimentary access to 12 months of credit monitoring and identity protection services.

In response to this incident, SHR notified law enforcement and engaged outside specialists to conduct a thorough forensic investigation. SHR is also reviewing its policies and procedures related to data protection and minimization and has taken additional steps to further enhance its network security and help decrease the chance of a similar incident occurring in the future.

Saratoga Harness Racing, Inc. ("SHR") writes to notify you of an incident that may affect the privacy of certain information provided to us. We take this incident seriously and are providing you with information about the incident, our response, and steps you can take to help safeguard your information.

On November 1, 2024, we experienced a network disruption that limited our ability to access certain files and systems on our network. We immediately began an investigation with the assistance of third-party specialists to determine the full nature and scope of the incident. The investigation determined that an unknown third-party potentially accessed some files on our network without authorization between October 31 and November 1, 2024. Therefore, we initiated a thorough review of the files at issue to determine the type of information they contained and to whom the information related.

While our review remains ongoing, we have determined the files at issue included SHR employee information, including your name in combination with [REDACTED].

In response to this incident, we notified law enforcement and engaged outside specialists to conduct a thorough forensic investigation. We are also reviewing our policies and procedures related to data protection and have taken additional steps to further enhance our network security and help decrease the chance of a similar incident occurring in the future.

We have no reason to believe any of the information concerning you described above has been or will be misused. However, in an abundance of caution, we are offering you complimentary access to twelve (12) months of credit monitoring and identity protection services. Instructions for enrolling in these free services and additional resources available to you are included in the enclosed *Steps You Can Take to Help Protect Your Information*.

## STEPS YOU CAN TAKE TO HELP PROTECT YOUR INFORMATION

### *Enroll in Credit Monitoring / Identity Protection*

In response to the incident, we are providing you with access to **Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score** services at no charge. These services provide you with alerts for twelve (12) months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

#### How do I enroll for the free services?

To enroll in Credit Monitoring services at no charge, please log on to [REDACTED] and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED].

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

### *Monitor Your Accounts*

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports and account statements for suspicious activity and to detect errors. Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., III, etc.);
2. Social Security number;
3. Date of birth;
4. Address for the prior two to five years;
5. Proof of current address, such as a current utility or telephone bill;
6. A legible photocopy of a government-issued identification card (e.g., state driver’s license or identification card); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.
