Re: Notice of Data Event

To Whom It May Concern:

We represent Concorde Investment Services (“Concorde”) located at 3909 Research Park Drive Suite 200, Ann Arbor, Michigan 48108 and are writing to notify your office of an incident that may affect the security of certain personal information relating to two (2) Maryland residents. By providing this notice, Concorde does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about August 12, 2024, Concorde became aware of suspicious activity potentially associated with an employee’s email account. They immediately launched an investigation to confirm the full nature and scope of the activity. The investigation determined that certain email accounts were accessed and potentially acquired without authorization between June 13, 2024 and August 19, 2024. Concorde thereafter undertook a thorough review of the potentially impacted emails and documents within the account to determine what information was potentially impacted, and to whom the information related. That review recently concluded.

The information that could have been impacted includes name and Social Security number.

Notice to Maryland Residents

On or about February 25, 2025, Concorde provided written notice of this incident to two (2) Maryland residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, Concorde moved quickly to investigate and respond to the incident, assess the security of Concorde systems, and identify potentially affected individuals. Concorde is also working to implement additional safeguards and training to its employees. Concorde is providing access to credit monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Concorde is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Concorde is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Concorde is providing written notice of this incident to relevant state regulators, as necessary.

Concorde Investment Services (“Concorde”) is writing to inform you of a recent incident that may impact the privacy of some of your personal information. While we are unaware of any attempted or actual misuse of your information, we are providing you with information about the incident, our response, and steps you may take to protect against any misuse of your information, should you feel it necessary to do so.

What Happened? On or about August 12, 2024, Concorde became aware of suspicious activity potentially associated with an employee’s email account. We immediately launched an investigation to confirm the full nature and scope of the activity. The investigation determined that certain email accounts were accessed and potentially acquired without authorization between June 13, 2024 and August 19, 2024. We thereafter undertook a thorough review of the potentially impacted emails and documents within the account to determine what information was potentially impacted, and to whom the information related. That review recently concluded.

What Information Was Involved? The information that may be impacted includes [Extra1]. Although we have no evidence to indicate any of your information was subject to actual or attempted misuse, Concorde is providing this notice to all impacted individuals out of an abundance of caution.

What We Are Doing. We take this incident and the security of your information seriously. This letter provides resources to assist you in protecting your personal information. We are also working to review our existing policies and procedures to implement additional security measures. As an added precaution, we are offering you access to [Extra2] months of credit monitoring services through Experian IdentityWorks at no cost to you. We encourage you to enroll in these services, as we are not able to act on your behalf to enroll you. Please review the instructions contained in the attached *Steps You Can Take to Help Better Protect Your Information* for additional information on these services.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You may also review the information contained in the attached *Steps You Can Take to Help Better Protect Your Information*.

Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for [Extra2] months.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
