RE: Data Breach Notification

To Whom It May Concern:

We serve as counsel for Tiger Aesthetics Medical, LLC ("Tiger") located at 5870 Pacific Center Blvd., San Diego, CA 92121 and write to provide notification of a recent data breach. By providing this notice, Tiger does not waive any rights or defenses under Maryland law, including the data breach notification statute.

On October 27, 2024, Tiger learned of potential unauthorized access to its network and immediately launched an investigation. The investigation determined that certain information stored on Tiger's network was accessed by an unauthorized party between October 18, 2024 and October 27, 2024. Therefore, Tiger conducted a review of the contents of the information to determine the type of information contained on Tiger's network. While the review was ongoing, Tiger provided their employee's preliminary notice of this incident and access to complimentary credit monitoring and identity protection services. On January 27, 2025, Tiger completed their review of the data and began to locate address information for individuals. On February 14, 2025, Tiger received the National Change of Address (NCOA) results for the notice population and identified approximately seven Maryland residents who may have been affected by this incident. The type of information may include an individuals' name and Social Security number.

On February 26, 2025, Tiger mailed written notice to the potentially affected individuals, which was comprised of current and former employees, via U.S. mail. A copy of the notice letter is attached as ***Exhibit A***. In an abundance of caution, Tiger is offering all individuals complimentary credit monitoring and identity protection services. Additionally, in response to this incident, Tiger conducted an investigation, notified law enforcement, changed network passwords, and reviewed its policies and procedures related to data protection.

Tiger Aesthetics Medical, LLC writes to notify you of an incident that may affect the privacy of certain information provided to us. This letter includes information about the incident, our response, and resources we are making available to you.

What Happened? On October 27, 2024, we discovered a potential data incident and immediately began an investigation. The investigation determined there was unauthorized access to certain information on our network between October 18, 2024 and October 27, 2024. Therefore, we conducted a review of the contents of the information to determine the type of information contained therein. On January 27, 2025, we completed our review and began confirming address information to provide notice.

What Information Was Involved? The type of information identified in our review may have included your name and the following: Social Security number and date of birth.

What We Are Doing. In response to this incident, we changed passwords and reviewed our policies and procedures. In an abundance of caution, we are providing individuals access to free credit monitoring and identity protection services.

What You Can Do. We encourage you to enroll in the services we are making available. Information about how to enroll in these services along with additional resources available to you are included in the enclosed *Steps You Can Take to Protect Your Information*. We also encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports/account statements for suspicious activity and to detect errors.

STEPS YOU CAN TAKE TO PROTECT YOUR INFORMATION

Enroll in Credit Monitoring / Identity Protection

In response to the incident, we are providing you and your family access to credit monitoring and identity protection services at no charge. These services provide you with alerts for 12 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company.

For Adults - To enroll in credit monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following code to receive services: **[Enrollment Code]**. In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

For Minors - To enroll in cyber monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following code to receive services: **[Enrollment Code]**. Once you have enrolled yourself, click on your name in the top right of your dashboard and select “Manage Family Protection” then “Add Family Member” to enroll your child. In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and an email account and will require enrollment by parent or guardian first. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Monitor Your Accounts

Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit www.annualcreditreport.com or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended fraud alert on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a credit freeze on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or



application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., III, etc.);
2. Social Security number;
3. Date of birth;
4. Address for the prior two to five years;
5. Proof of current address, such as a current utility or telephone bill;
6. A legible photocopy of a government-issued identification card (e.g., state driver's license or identification card); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.

Additional Information

You can further educate yourself regarding identity theft, fraud alerts, credit freezes, and the steps you can take to protect your personal information by contacting the credit reporting bureaus, the Federal Trade Commission (FTC), or your state Attorney General. The FTC also encourages those who discover that their information has been misused to file a complaint with them. You have the right to file a police report if you ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, you will likely need to provide some proof that you have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement, your state Attorney General, and the FTC. This notice has not been delayed by law enforcement.
