Re: Notice of Data Event

To Whom It May Concern:

We represent McLanahan Corporation (“McLanahan”) located at 200 Wall Street, Hollidaysburg, Pennsylvania 16648, and are writing to notify your office of an incident that may affect the security of certain personal information relating to two (2) Maryland residents. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, McLanahan does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

In 2024, McLanahan discovered suspicious activity in its environment. Upon learning this, McLanahan promptly launched an investigation to determine the nature and scope of the activity. The investigation determined there was likely unauthorized access to the McLanahan environment between February 23 and March 9, 2024. The investigation also determined that an unauthorized actor copied certain information stored on the network during this period of time. Therefore, McLanahan undertook a comprehensive review of the data at risk to assess if any sensitive information could be affected and to whom it related. This review and the subsequent enrichment to identify missing contact information took a significant amount of time. On January 6, 2025, McLanahan completed this review and took steps to notify the potentially impacted individuals.

The information that could have been subject to unauthorized access for Maryland residents includes name, group insurance/subscriber number, Social Security number, and other health insurance information.

Notice to Maryland Residents

On February 28, 2025, McLanahan began providing written notice of this incident to two (2) Maryland residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, McLanahan moved quickly to investigate and respond to the incident, assess the security of McLanahan systems, and identify potentially affected individuals. Further, McLanahan notified federal law enforcement regarding the event. McLanahan is also working to implement additional safeguards and training to its employees. McLanahan is providing access to credit monitoring services for twelve (12) months, through TransUnion, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, McLanahan is providing impacted individuals with guidance on how to better protect against identity theft and fraud. McLanahan is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

McLanahan is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

NOTICE OF SECURITY INCIDENT

Dear

McLanahan Corporation (“McLanahan”) writes to notify you of an incident which may affect the privacy of some of your information. This letter provides details of the incident, our response, and steps you may take to better protect against the possible misuse of your information should you feel it is appropriate to do so.

What Happened? Last year, McLanahan discovered suspicious activity in its environment. Upon learning this, McLanahan promptly launched an investigation to determine the nature and scope of the activity. The investigation determined there was likely unauthorized access to our environment between February 23 and March 9, 2024. The investigation also determined that an unauthorized actor copied certain information stored on our network during this period of time. Therefore, McLanahan undertook a comprehensive review of the data at risk to assess if any sensitive information could be affected and to whom it related. On January 6, 2025, McLanahan completed this review and determined the data contained certain information related to you.

What Information Was Involved? McLanahan determined the type of information potentially impacted by this incident includes: your name and employer assigned identification number, medical billing/claims information, group insurance/subscriber number, payment card number, account number, account number with routing number, health insurance certificate number, Social Security number, card type, date of birth, other health insurance information, and other unique identifier.

What We Are Doing. McLanahan takes the confidentiality, privacy, and security of information in its care seriously. Upon discovery of the incident, we immediately commenced an investigation and took steps to implement additional safeguards and review our policies and procedures relating to data privacy and security.

In an abundance of caution, McLanahan is providing you with access to **twelve (12)** months of credit monitoring and identity protection services through TransUnion at no cost to you. A description of the services and instructions on how to enroll can be found within the enclosed *Steps You Can Take to Protect Personal Information*. Please note that you must complete the enrollment process yourself as we are not permitted to enroll you in these services.

What You Can Do. You can review the enclosed *Steps You Can Take to Protect Personal Information* for general guidance. In addition, you can enroll in the complimentary credit monitoring and identity protection services being offered through TransUnion. We also encourage you to remain vigilant against incidents of

identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious activity.

Steps You Can Take To Protect Personal Information

Enroll in Monitoring Services

You can follow the recommendations on the following page to help protect your personal information. You can also enroll in the complimentary credit monitoring services being offered to you by logging on to <https://bfs.cyberscout.com/activate> and following the provided instructions. When prompted, please provide the following unique code: . To receive the monitoring services, please enroll within 90 days from the date of this letter. The enrollment requires an internet connection and email account and may not be available to minors. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission may be reached at: 600 Pennsylvania Avenue NW, Washington, D.C. 20580; www.identitytheft.gov; 1-877-ID-THEFT (1-877-438-4338); and TTY: 1-866-653-4261. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers can obtain further information on how to file such a complaint by way of the contact information listed above. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
