Re: Incident Notification

Dear Sir or Madam:

We are writing on behalf of our client, iTP Partners, to notify your office of a cybersecurity incident.

iTP Partners concluded an investigation into an incident involving unauthorized access to employee email accounts. Upon learning of the incident, iTP Partners took measures to secure the email accounts and began an investigation. The evidence showed that an unauthorized actor accessed the email accounts at different times beginning on March 15, 2024 and ending on March 22, 2024. iTP Partners reviewed the emails and attachments that were potentially involved and, on December 6, 2024, determined that one or more of them contained the names, Social Security numbers, and financial account numbers of 16 Maryland residents.

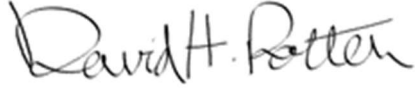
On February 28, 2025, iTP Partners will mail notification letters to the Maryland residents via United States First-Class mail. A copy of the notification letter is enclosed. iTP Partners is offering the residents one year of complimentary credit monitoring and identity theft restoration services through Equifax. iTP Partners has also established a dedicated call center that individuals can call to obtain more information regarding the incident.

To help prevent something like this from happening again, iTP Partners has taken steps to enhance its existing security measures.

iTP Partners is writing to inform you that we identified and addressed an email phishing incident that involved some of your information. iTP Partners is an entity not affiliated with Osaic Wealth, Inc. (“Osaic”) but whose financial professionals are registered with Osaic for the sale of securities products and provision of financial advice. This letter explains the incident, outlines the measures we have taken, and provides steps you can take in response.

We took immediate steps to secure the accounts and launched an investigation. Our investigation determined that an unauthorized individual accessed the email accounts at different times. Our investigation was not able to determine which, if any, emails were accessed within the accounts involved. We reviewed the emails and attachments that may have been accessed in the mailbox, which was a time intensive project. On December 6, 2024 we determined that one or more emails or attachments in the mailbox included your name in combination with your <<Breached Elements>>.

While we could not determine if your specific information was accessed, we are notifying you out of an abundance of caution. On a positive note, this incident did not affect Osaic computer systems and there is no impact to these associated systems or data. Furthermore, your advisor has experienced no disruptions in servicing your account.

Your confidence and trust are important to us, and we regret any inconvenience or concern this incident may cause. To help prevent a similar incident from occurring in the future, we have implemented additional technical safeguards to better protect our email system. We are also offering you a free one-year membership to Equifax Complete Premier. This product helps detect any misuse of your personal information and provides you with identity protection services that focus on immediate identification and resolution of any instance of identity theft. Equifax Complete Premier is completely free to you, and enrolling in this program will not affect your credit score. For more information on identity theft prevention, including instructions on how to activate your complimentary membership and additional steps you can take to help protect yourself, please see the additional information provided with this letter.

We remind you that it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity over the next 12 to 24 months. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
