Re: Cybersecurity Event Involving Legacy Works.

Dear Attorney General Brown:

Wilson Elser Moskowitz Edelman and Dicker LLP (“Wilson Elser”) represents Administration & Support, Inc. dba: Legacy Works (“Legacy Works”), a labor union located at 1164 Bishop Street, #805, Honolulu, HI 96813, with respect to a recent cybersecurity event that was first discovered by Legacy Works on October 10, 2024 (hereinafter, the “Event”). Legacy Works takes the security and privacy of the information in its control very seriously, and has taken steps to prevent a similar event from occurring in the future.

This letter will serve as notice of the nature of the Event, what information may have been compromised, the number of Maryland residents being notified, and the steps that Legacy Works has taken in response to the Event. We have also included with this letter a sample of the notification made to the potentially impacted individuals, which includes an offer of free credit monitoring services. By providing this notice, the Legacy Works does not waive any rights or defenses regarding the applicability of the Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

1. Nature of the Event

On October 10, 2024, Legacy Works became aware of suspicious activity within its email environment. Legacy Works promptly took steps to secure its environment and engaged a specialized cybersecurity firm to investigate the nature and scope of the incident. Legacy Works’ investigation has determined that certain data was potentially accessed and acquired by a third party not authorized to do so.

Legacy Works then began a comprehensive review of the data set to understand whose information was affected. On March 3, 2025, Legacy Works concluded a comprehensive review of the data set to understand what information was affected. Legacy Works has notified everyone out of full transparency. The following types of information may have been impacted: Name,

Bank/Financial Account Number, and Social Security number. The type of information at issue varies for each person.

2. Number of Maryland residents affected.

A total of 1 Maryland resident(s) may have been potentially affected by this event. Notification letters to these individuals were mailed on March 14, 2025, via first class mail. A sample copy of the notification letter is included with this letter under **Exhibit A**.

3. Steps taken in response to the Event.

Legacy Works is committed to ensuring the security and privacy of all personal information in its control and is taking steps to prevent a similar event from occurring in the future. Upon discovery of the Event, Legacy Works moved quickly to investigate and respond to the Event, assessed the security of its systems, and notified the potentially affected individuals. Specifically, Legacy Works engaged a specialized cybersecurity firm to conduct a forensic investigation to determine the nature and scope of the Event. Legacy Works informed our law firm and began identifying the potentially affected individuals in preparation for notice. Although Legacy Works is not aware of any actual or attempted misuse of the affected personal information, Legacy Works offered 12-24 months of complimentary credit monitoring and identity theft restoration services.

Notice of Data Breach

Administration & Support, Inc. dba: Legacy Works (“Legacy Works”) is writing to inform you of a recent data security incident that may have resulted in unauthorized access to your data. We are providing you with details about the incident, steps we are taking in response, and resources available to help you protect against the potential misuse of your data. Please be assured Legacy Works takes the protection and proper use of your data very seriously.

What Happened?

On October 10, 2024, Legacy Works became aware of suspicious activity within its email environment. Legacy Works promptly took steps to secure its environment and engaged a specialized cybersecurity firm to investigate the nature and scope of the incident. Legacy Works’ investigation has determined that certain data was potentially accessed and acquired by a third party not authorized to do so.

Legacy Works then began a comprehensive review of the data set to understand whose information was affected. On March 3, 2025, Legacy Works concluded a comprehensive review of the data set to understand what information was affected. Legacy Works is notifying everyone out of full transparency because information related to you may have been accessed and acquired without your authorization.

What Information Was Involved?

Some combination of the following data was potentially accessed and acquired by a person not authorized to view it: Name, Social Security Number and Bank/Financial Account Number.

What Are We Doing?

Data security is one of our highest priorities. Upon detecting this incident, we moved quickly to initiate an investigation to remediate the incident and confirm the security of our environment. We take the protection and proper use of personal information very seriously and plan to enhance the security of our systems moving forward in an effort to prevent any further similar incidents.

As part of our ongoing commitment to information privacy and the security of information, we are notifying you of this incident, and we are providing you with access to **Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score** services at no charge. These services provide you with alerts for 12 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

What You Can Do

We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious or unauthorized activity. Additionally, security experts suggest that you contact your financial institution and all major credit bureaus to inform them of such a breach and then take whatever steps are recommended to protect your interests, including the possible placement of a fraud alert on your credit file. Please review the enclosed *Steps You Can Take to Help Protect Personal Information*, to learn more about how to protect against the possibility of information misuse.

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED]. Please note that the code is case-sensitive and will need to be entered as it appears.

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Once enrolled you will have 12 months of monitoring services. At the end of 12 months the services will be deactivated. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Representatives are available for 90 days from the date of this letter, to assist you with questions regarding this event, between the hours of 8:00 a.m. to 8:00 p.m. Eastern time, Monday through Friday, excluding holidays. Please call the help line 1-800-405-6108 and supply the fraud specialist with the unique code listed above. The call center representatives have been fully versed in the event and can answer questions or concerns you may have regarding the protection of your personal information.

At Legacy Works, we take our responsibility to protect your personal information very seriously. We are deeply disturbed by this situation and apologize for any inconvenience.

Steps You Can Take to Help Protect Personal Information

Credit Reports: You may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the three nationwide credit reporting agencies. To order your free credit report, please visit www.annualcreditreport.com, or call toll-free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available at <https://www.consumer.ftc.gov/articles/0155-free-credit-reports>) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281.

Security Freeze: You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze. You may also place a security freeze for children under the age of 16. You may obtain a free security freeze by contacting any one or more of the following national consumer reporting agencies:

Fraud Alerts: You can place fraud alerts with the three credit bureaus by phone and online with:

- Equifax (https://assets.equifax.com/assets/personal/Fraud_Alert_Request_Form.pdf);
- TransUnion (<https://www.transunion.com/fraud-alerts>); or
- Experian (<https://www.experian.com/fraud/center.html>).

A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. As of September 21, 2018, initial fraud alerts last for one year. Victims of identity theft can also get an extended fraud alert for seven years. The phone numbers for all three credit bureaus are at the bottom of this page.

Monitoring: You should always remain vigilant and monitor your accounts for suspicious or unusual activity.

File Police Report: You have the right to file or obtain a police report if you experience identity fraud. Please note that in order to file a crime report or incident report with law enforcement for identity theft, you will likely need to provide proof that you have been a victim. A police report is often required to dispute fraudulent items. Instances of known or suspected identity theft should also be reported to law enforcement or to the Attorney General's office in your home jurisdiction. This notice has not been delayed by law enforcement.



FTC and Attorneys General: You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General. For New Mexico residents, state law advises you to review personal account statements and credit reports, as applicable, to detect errors resulting from the security breach. You also have rights pursuant to the Fair Credit Reporting Act, such as the right to be told if information in your credit file has been used against you, the right to know what is in your credit file, the right to ask for your credit score, and the right to dispute incomplete or inaccurate information. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit "prescreened" offers of credit and insurance you get based on information in your credit report; and you may seek damages from violators. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
