Re: Notice of Data Event

To Whom It May Concern:

We represent Martin Snow, LLP (“Martin Snow”) located at Post Office Box 1606, Macon, Georgia 31202-1606, and are writing to notify your office of an event that may affect the security of certain personal information relating to nineteen (19) Maryland residents. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Martin Snow does not waive any rights or defenses regarding the applicability of Maryland law, the applicability of the Maryland data event notification statute, or personal jurisdiction.

Nature of the Data Event

On June 10, 2024, Martin Snow observed unexpected activity in its network. Martin Snow promptly took steps to ensure the ongoing security of its systems and investigated the nature and scope of the observed activity. The investigation determined that someone without authorization accessed certain files on Martin Snow’s network between April 2, 2024, to April 4, 2024. Martin Snow reviewed thoroughly the accessible data to determine what information was present and to whom that information related. Martin Snow completed its review of the accessible data on December 26, 2024, and identified some personal information related to individuals. Martin Snow then worked to locate relevant address information to enable notice to occur. These efforts have recently concluded, and Martin Snow has begun notifying appropriate parties.

The information that could have been subject to unauthorized access includes name, Social Security number, and taxpayer identification number.

Notice to Maryland Residents

On or about March 18, 2025, Martin Snow provided written notice of this event to nineteen (19) Maryland residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon becoming aware of the event, Martin Snow moved quickly to investigate and respond to the event, assess the security of Martin Snow systems, and identify potentially affected individuals. Further, Martin Snow notified federal law enforcement regarding the event. Martin Snow is also working to implement additional safeguards and training to its employees. Martin Snow is providing access to credit monitoring services for twelve (12) months, through Equifax, to individuals whose personal information was potentially affected by this event, at no cost to these individuals.

Additionally, Martin Snow is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Martin Snow is providing individuals with information on how to place fraud alerts and credit freezes on their credit files, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Martin Snow is providing written notice of this event to relevant state regulators.

Martin Snow, LLP (“Martin Snow”) writes to inform you of an event that involves your personal information. This letter provides information about the event, our response, and the resources available to you to help protect your information from possible misuse, should you feel it appropriate to do so.

What Happened. On June 10, 2024, Martin Snow observed unexpected activity in our network. We promptly took steps to ensure the ongoing security of our systems and investigated the nature and scope of the observed activity. The investigation determined that someone without authorization accessed certain files on our network between April 2, 2024, to April 4, 2024. We reviewed thoroughly the accessible data to determine what information was present and to whom that information related. We completed our review of the accessible data on December 26, 2024, and identified some of your personal information in it. We then worked to ensure that we had proper mailing information to issue this notice to you. Our efforts recently concluded, and we are contacting you to let you know what we learned.

What Information Was Involved. The personal information related to you in the accessible data includes your name and the following: <<Breached Elements>>.

What We Are Doing. We take this event and the security of information in our care seriously. We investigated the observed activity, ensured the ongoing security of our network, and notified individuals whose data we located during our review. As part of our ongoing commitment to information security, we continue to review our already robust security measures as well as our policies and procedures in our effort to reduce the likelihood of similar future events. We notified federal law enforcement and will be notifying relevant regulators, as required.

As an added precaution, we are also offering <<12/24>> months of complimentary access to credit monitoring services through Equifax. Individuals who wish to receive these services can enroll by following the enrollment instructions contained in the *Steps You Can Take to Help Protect Personal Information*. We are unable to enroll you on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring free credit reports for suspicious activity and to detect errors. Suspicious activity should be promptly reported to relevant parties, such as your financial institution. Additional information and resources may be found below in the *Steps You Can Take to Help Protect Personal Information*.

WebScan searches thousands of Internet sites where consumers’ personal information is suspected of being bought and sold, and regularly adds new sites to the list of those it searches. However, the Internet addresses of these suspected Internet trading sites are not published and frequently change, so there is no guarantee that we are able to locate and search every possible Internet site where consumers’ personal information is at risk of being traded. ²The Automatic Fraud Alert feature is made available to consumers by Equifax Information Services LLC and fulfilled on its behalf by Equifax Consumer Services LLC. ³Locking your Equifax credit report will prevent access to it by certain third parties. Locking your Equifax credit report will not prevent access to your credit report at any other credit reporting agency. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial, as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers can obtain further information on how to file such a complaint by way of the contact information listed above. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
